

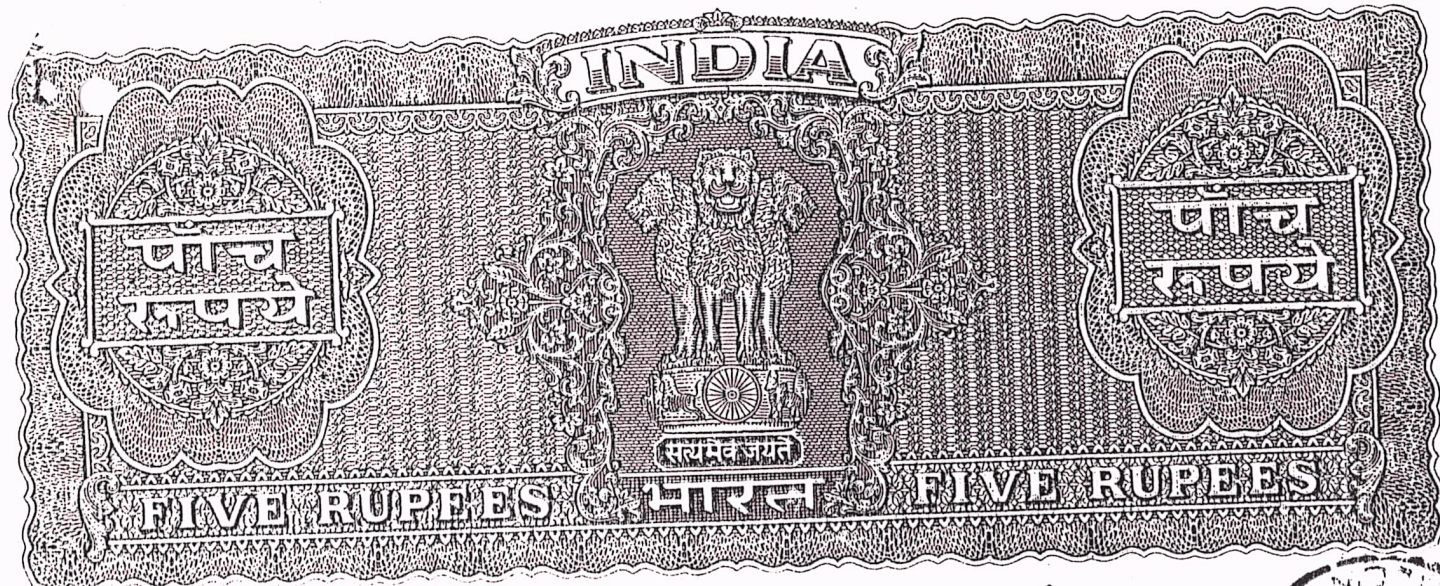

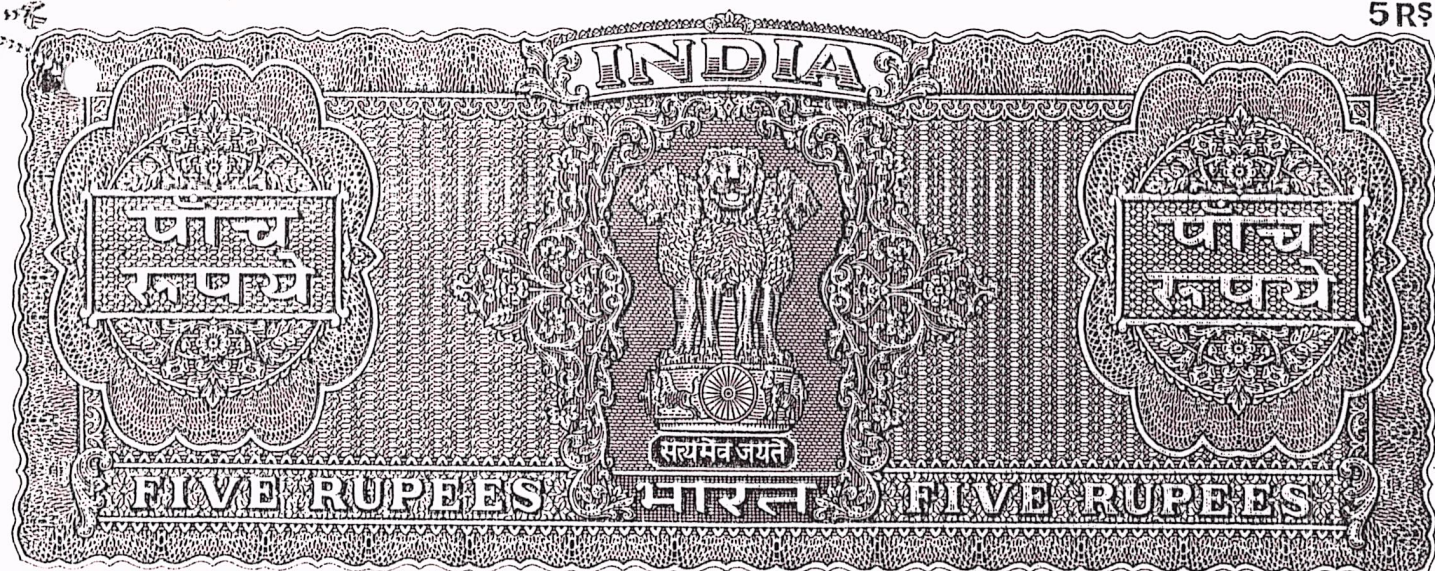

4 ENDOWMENT: The Archdiocese shall deposit a sum of Rupees thirty lakhs (Rs.30,00,000/-) in the form of an endowment (hereinafter referred to as "THE CORPUS" in this memorandum) for creating the ESCANDE Chair in Asian Christian Studies. The corpus shall be invested in a Nationalised Bank on a long term deposit. The interest accrued shall be utilised to pay the incumbent the salary on par with other professors of the University. If there is any balance it shall be added to the Corpus.

b) Adequate teaching experience / in Universities or in Pontifical Theological Institutes / Publication of Asian Christian Studies.

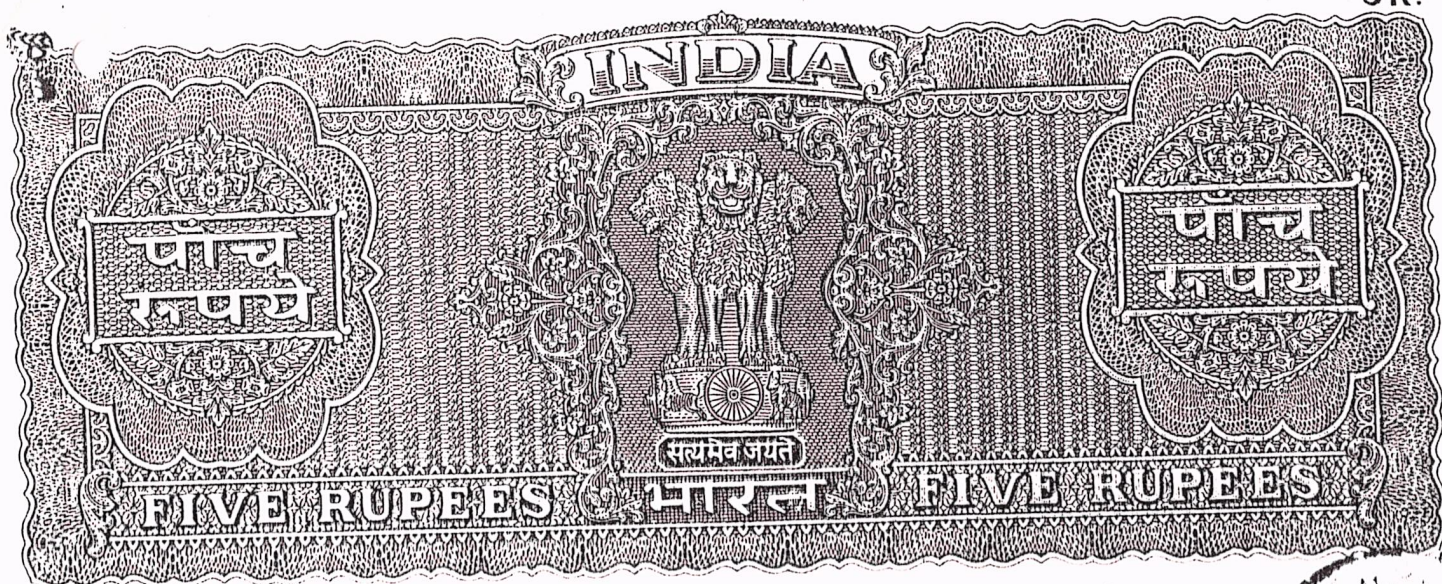

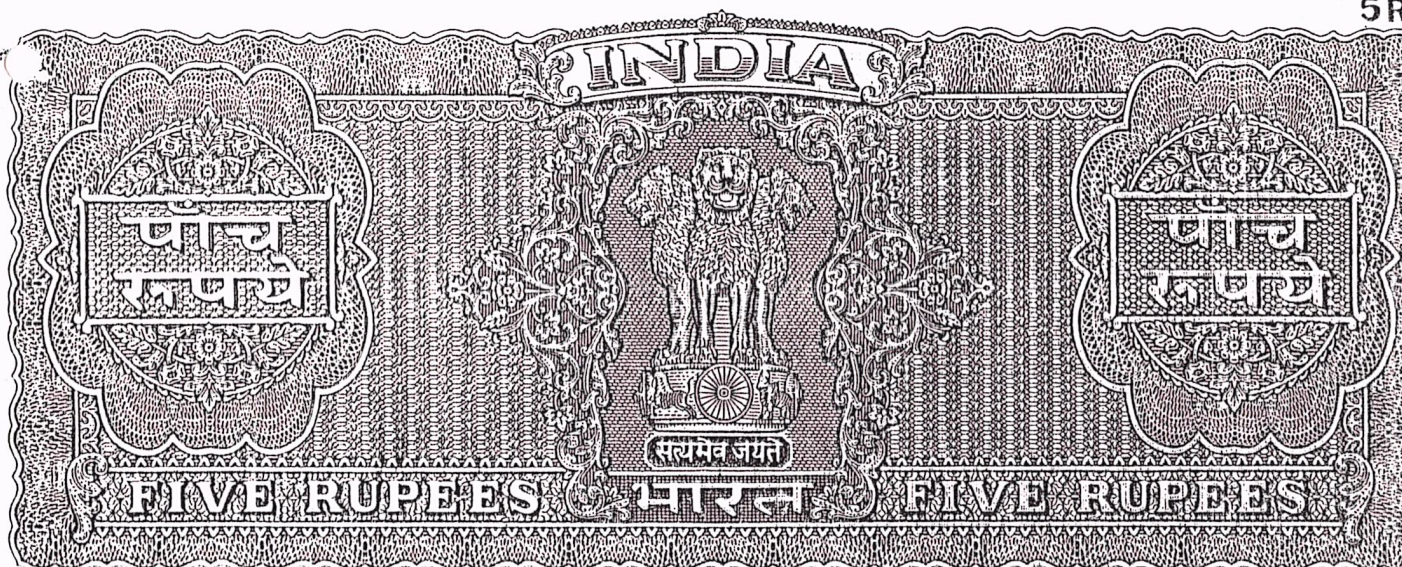
