Sub: Submission of report on students misbehavior at Fresher's Day celebration – reg.

Members of the enquiry committee met on 09.01.2024 at 11 AM in the faculty room of Prof. S. It is noted that Department of Banking Technology second year students jointly organized Fresher's Day celebration on 16.12.2023 at Convention cum Cultural Centre (CCC). It is learnt from reliable source that there was a quarrel between second year and first year students of the Department. In this regard, the enquiry began with three students of MBA II (FT). They said that MBA (FT) and MBA (BT) first year students were performing dance on the stage. Suddenly, a group of students started shouting at each other at the back side of hall. The group had Rahul MBA II (BT), Sharan MBA II (FT), Karthik MBA I (FT), Balaji MBA I (FT), and Rakesh Sharma (Other Department). The second year students of FT said that Rahul pushed and patted at Karthik (FT). The second year students said that Karthik and Rakesh Sharma allegedly misbehaved and disturbed the event. This appears to be the root cause for the quarrel. Further, the second year students of MBA (BT) also made the same narrative. Finally, Karthik and Balaji appeared before the committee and explained the incident sequentially.

Facts found by the committee:

- 1. Second year students were provoked by the Karthik and Rakesh Sharma.
- 2. Rakesh Sharma continuously uttered un-parliamentarian words.
- 3. Karthik and Rakesh Sharma were drunk. This is stated from self-explanatory statement made by him. Balaji was just with Karthik but remained non-disruptive.
- 4. The quarrel did not escalate rather it is completely settled.
- 5. Second year students forgot and forgave the incident and they want to remain friendly with all first year students.
- 6. Karthik tendered apology.
