**TO CONSIDER WAIVING OF THE LIBRARY DUES PENDING AGAINST
DR. K. SARAVANAN, ASSISTANT LIBRARIAN, (RETD.),
PONDICHERRY UNIVERSITY COMMUNITY COLLEGE,
PONDICHERRY**

Dr. K. Saravanan, Assistant Librarian, Community College, Pondicherry was relieved from the services of this University w.e.f. 31.10.2016 (Monday) consequent on attaining the age of superannuation (62 years).

A two member committee was appointed with the composition of Dr. U. Nagalingam, Deputy Librarian, and Dr. M. Baskar, Assistant Librarian to visit the Library of Pondicherry University Community College and to do the thorough check of stock verification of the Pondicherry University Community College Library and submit a report.

Dr. R. Samyuktha, Librarian, Central Library has informed that on perusal of the report, it is found that out of total collection of 7955 Books, 813 Books were found to be missing for past 20 years. The total cost of the missing 813 Books comes to Rs.2,03,452/-.(copy enclosed)

It is also stated in the Report that, as per GFR 194, for every 1000 books consulted, 5 books can be written off. On an average, 50 books were consulted per day at the Pondicherry University Community College Library. For 20 years, 1500 books can be written off as per the GFR 194.(copy enclosed)

In the present case, the total missing books for 20 years, comes to 813, which is well within the permissible written-off limit.

The Librarian and the committee in an report has recommended for waiving it.

On the earlier occasion, the Library dues pending against Late Dr. A. Balasubramanian, Reader in Physics towards 20 missing books costing of Rs. 7,594/- has been written off as per the 92nd Executive Council decision vide

resolution No.2006.247, dated 30.12.2006 and late Prof. S.V. Narayanan, Professor of Management Studies towards 60 books costing of Rs.13,823.30/- has also been written off as per the 93rd Executive Council decision vide Resolution No.2007.07, dated 17.05.2007.

Hence, it is submitted before the Council to consider waiving of Rs.2,03,452/- towards the cost of the 813 books missing in the Pondicherry University Community College Library for the past 20 years as per the recommendation of the Librarian and also by taking into consideration the decisions taken previously in the case of Late Dr. A. Balasubramanian, Reader in Physics and late Prof. S.V. Narayanan, Professor of Management Studies.



With reference to the letter cited (1) above from then Principal i/c., Prof. Mohanan Bhaskaran Pillai, it was informed that Stock Verification of the Library Books of PUCC Library was done and requested to write-off the lost books as per GFR Rules, as the Assistant Librarian, Dr. K. Saravanan was retiring in the month of October, 2016. With reference to the letter cited (2) above, it was suggested by the Librarian that since the complete details were not indicated regarding the loss of Books in Prof. Mohanan Pillai's letter, a two member committee consisting of Dr. U.Nagalingam, Deputy Librarian and Dr. M. Baskar, Assistant Librarian may be appointed to do thorough check of Stock Verification of the PUCC Library. With reference to the letter cited (3) above, approval was given for the Stock Verification to be done by the two member committee and since then Stock Verification was done and a detailed report with five Annexures submitted on 15.12.2016 is forwarded now for necessary action.

On perusal of the report, it is found that out of total collection of 7955 Books, 813 Books were found missing. Of these books, literally missing were 392 + 24 Books and the remaining were long over due for a period of 20 years since 1996 by passed-out students, faculty and staff (Details are available in the annexed report). Keeping in view of the GFR 194 that for every 1000 Books consulted, 5 Books can be written-off, in this case, since the accumulated missing 813 Books comes well within the permissible limit, it is recommended to be written-off as per the University procedures. On doing so, it would settle issues kept pending for the last 20 years and would make way for further governance and functioning of the PUCC as the Asst. Librarian, Dr. K. Saravanan retired on October 2016 and in his place Mr. N. Sankarasubramanian has been transferred from the Central Library to take charge of the PUCC Library.

Hence, it is recommended as per this report, necessary action may be taken for writing-off the 813 Books of total value of Rs.2,03,452/- and settle the retirement benefits for Dr. K. Saravanan.

With reference to the Letter Ref. No.PU/Estt(T)/ET-7/2016-17/113 dated 19.10.2016, a two member committee consisting of Dr. U. Nagalingam, Deputy Librarian and Dr. M. Baskar, Assistant Librarian was constituted to cross check the stock verification report forwarded by the former Principal, Community College.

In this regard, stock verification of the entire collection of 7955 books was carried out and the full report is submitted.

Detailed Report of the Committee: -

- a) The total library collection of Community College Library is 7955 as per the Accession Registers Nos.I to VI. The committee inspected the Community College Library and all the Books had been physically scanned and verified through Barcode Scanner and found that totally 7166 Books were available and 789 Books were missing as on 25.10.2016.
- b) The Committee also cross checked the Bibliographical details of all the books with its accession numbers and found in order.
- c) A total no. of 471 books were purchased under the head JET, Govt. of Puducherry Training Programme in 1998. **24 books** are missing from this for the value of Rs.7,935/-.
- d) Finally, it was found that totally **789 Nos. of books** were physically not available in the library in the different categories such as missing / long overdue by the University faculty/staff / Students for more than 20 years. The details of books not available and long overdue are separately categorized in four annexures as per the details given below: -

JUSTIFICATION

The Stock Verification for the Library of Pondicherry University Community College (PUCC) was conducted in the month of October 2016. Since 1996 to 2016, i.e. 20 years, the accumulated missing books were not written off after stock verification.

As per the Stock Verification report of PUCC Library, it is found that 813 Books (789 + 24) were missing.

As per GFR 194, for every 1000 books consulted 5 books can be written-off. Even on an average, if 50 books were consulted per day at the Community College Library, for 20 years (1996 to 2016), 1500 books can be written off as per GFR 194. Here, in this case, the accumulated missing books for 20 years is **813** and since it comes well within the permissible limit, it is recommended that it may be written-off.

General Financial Rules, 2005

**Government of India
Ministry of Finance
Department of Expenditure**

Note : These forms can be supplemented with additional details by Ministries/Departments as required.

Rule 191. Hiring out of Fixed Assets : When a fixed asset is hired to local bodies, contractors or others, proper record should be kept of the assets and the hire and other charges as determined under rules prescribed by the competent authority, should be recovered regularly. Calculation of the charges to be recovered from the local bodies, contractors and others as above should be based on the historical cost.

Rule 192.

- (1) **Physical verification of Fixed Assets :** The inventory for fixed assets shall ordinarily be maintained at site. Fixed assets should be verified at least once in a year and the outcome of the verification recorded in the corresponding register. Discrepancies, if any, shall be promptly investigated and brought to account.
- (2) **Verification of Consumables :** A physical verification of all the consumable goods and materials should be undertaken at least once in a year and discrepancies, if any, should be recorded in the stock register for appropriate action by the competent authority.
- (3) **Procedure for verification :**
 - (i) Verification shall always be made in the presence of the officer, responsible for the custody of the inventory being verified.
 - (ii) A certificate of verification alongwith the findings shall be recorded in the stock register.
 - (iii) Discrepancies, including shortages, damages and unserviceable goods, if any, identified during verification, shall immediately be brought to the notice of the competent authority for taking appropriate action in accordance with provision given in **Rule 33 to 38**.

Rule 193. Buffer Stock : Depending on the frequency of requirement and quantity thereof as well as the pattern of supply of a consumable material, optimum buffer stock should be determined by the competent authority.

Note : As the inventory carrying cost is an expenditure that does not add value to the material being stocked, a material remaining in stock for over a year shall generally be considered surplus, unless adequate reasons to treat it otherwise exist.

Rule 194. Physical verification of Library books

- (i) Complete physical verification of books should be done every year in case of libraries having not more than twenty thousand volumes. For libraries having more than twenty thousand volumes and upto fifty thousand volumes, such verification should be done at least once in three years. Sample physical verification at intervals of not more than three years should be done in case of libraries having more than fifty thousand volumes. In case such a verification reveals unusual or unreasonable shortages, complete verification shall be done.
- (ii) Loss of five volumes per one thousand volumes of books issued/consulted in a year may be taken as reasonable provided such losses are not attributable to dishonesty or negligence. However, loss of a book of a value exceeding Rs. 1,000/- (Rupees One thousand only) and rare books irrespective of value shall invariably be investigated and appropriate action taken.

Rule 195. Transfer of charge of goods, materials etc. : In case of transfer of Officer-in-charge of the goods, materials etc., the transferred officer shall see that the goods or material are made over correctly to his successor. A statement giving all relevant details of the goods, materials etc., in question shall be prepared and signed with date by the relieving officer and the relieved officer. Each of these officers will retain a copy of the signed statement.

Rule 196. Disposal of Goods.

- (i) An item may be declared surplus or obsolete or unserviceable if the same is of no use to the Ministry or Department. The reasons for declaring the item surplus or obsolete or unserviceable should be recorded by the authority competent to purchase the item.
- (ii) The competent authority may, at his discretion, constitute a committee at appropriate level to declare item(s) as surplus or obsolete or unserviceable.
- (iii) The book value, guiding price and reserved price, which will be required while disposing of the surplus goods, should also be worked out. In case where it is not possible to work out the book value, the original purchase price of the goods in question may be utilised. A report of stores for disposal shall be prepared in Form GFR - 17.
- (iv) In case an item becomes unserviceable due to negligence, fraud or mischief on the part of a Government servant, responsibility for the same should be fixed.

**RENEWAL OF MEMORANDUM OF UNDERSTANDING
BETWEEN
PONDICHERRY UNIVERSITY
AND
THE INSTITUTE OF BIOINFORMATICS (IOB), BANGALORE.**

Pondicherry University, a Central University, established under University Act 1985, Govt. of India., located at R. Venkataraman Nagar, Kalapet, Puducherry and the Institute of Bioinformatics, Discoverer Building, 7th Floor, International Technology Park, Whitefield Road, Bangalore engaged in research in bioinformatics, proteomics, genomics and systems biology, hereinafter referred to as "IOB" agree to establish mutual cooperation and pedagogical relations in the interest of contributing to the development of research/higher education in the field of bioinformatics or any other discipline of mutual interest

In accordance with the initial agreement signed in May 2009, IOB expresses its intent to renew the same. IOB together with the Departments and Centers of Pondicherry University have already exchanged a few scholarly students actively carrying out research in the fields of bioinformatics, proteomics and molecular biology. Based on mutual consent, we hereby agree to continue the active collaboration for an additional term of five years.

(1) The specific objectives of the collaborative endeavor is to develop research and training programs beneficial to both institutions. Cooperation shall be in the fields of (i) curriculum development (ii) conducting training programs/seminars/workshops (iii) research collaboration, etc., for effective implementation of the post-graduate study programs, doctoral and advanced research programs.

They are to be achieved by way of:

- (a) Joint research activities on a mutual and reciprocal basis. This will be achieved by registering the students selected by 'IOB' through their stringent selection process as per UGC rules and regulations for Ph.D. degree of Pondicherry University under the joint supervision of the guides of IOB and Pondicherry University recognized by the University. The students will be subjected to the rules and regulations of UGC and Pondicherry University. Any publications resulting from such collaborations shall be duly credited
- (b) A faculty member of Centre for Bioinformatics will be a co-guide for each student selected for carrying out Ph.D. at IOB under this MOU.
- (c) IOB agrees for faculty exchange between IOB and Pondicherry University which will involve visits of partner institute at least once a year for a minimum period of two weeks towards activities involving teaching course work and seminars on cutting-edge research.

- (d) Joint grant applications to Indian and foreign funding agencies would be submitted involving faculty and other manpower available at both the places. Depending upon the field of research and expertise in the area, the principal and co-investigators will be decided on case by case basis. Equipment, requested in joint projects with the consent of both the parties, will remain at the place where the work is proposed to be carried out and approved by the funding agency.
- (e) Exchange of information and publication on the successful completion of the research projects.
- (2) IOB should provide a undertaking to the effect that all the Ph.D rules and regulations promulgated by UGC and PU from time-to-time will be strictly followed.
- (3) The program will be subjected to the approval by the highest decision making authorities of the University viz. the Academic Council, the Executive Council and the Vice-Chancellor of the University. This MOU will normally be effective only from the date of final approval. The University shall follow the guidelines of the University Grants Commission, New Delhi and the Ministry of Human Resource Development, Govt. of India issued by them from time to time.
- (4) In order to implement the programs effectively, each of the institutions will have a program advisory committee with a nominated coordinator from each place that will be responsible for the effective implementation of the program. As and when required, joint committee meetings would be arranged. The coordinators can be changed during the period of the MOU.
- (5) Ten students from 4th semester M.Sc. or M.Tech. programme at Pondicherry University will be selected every year to carry out academic projects at IOB in ongoing projects under the common guidance of faculty from IOB and Pondicherry University. Boarding and lodging for this period will be borne by IOB.
- (6) In case of termination of the MOU, the Ph.D. students registered during this period shall be allowed to submit their thesis even after the expiry of the period, but within the maximum time limit prescribed in the Ph.D. regulations. However, the Pondicherry University shall strive to revive any MOU expired for the benefit of its personnel.
- (7) The faculty/scholars/students/technical staff/researchers will be eligible for exchange with the institutions under MOU.
- (8) It is understood that faculty members and research scholars of Pondicherry University and scientists and research scholars at IOB may utilize the existing facilities (both laboratory and instruments) available in either institution at free of charge by bearing consumables at their own cost.

(9) IOB and the Centre for Bioinformatics of the PU shall submit progress reports at the end of each year to the Registrar of the Pondicherry University.

(10) Faculty from the University who visit IOB shall be given duty leave as per Pondicherry University rules in force from time to time.

(11) The intellectual property generated during the course of collaboration shall not be patented or used for commercial exploitation by any one of the institutions without the written permission of the other. The patent shall, as far as possible, be registered in joint names. If one party abandons its claim or fails to give a reply within a period of ninety days, the other party will be free to register the patent in its own name. This agreement is accordingly entered between Pondicherry University, Puducherry and the Institute of Bioinformatics (IOB), Bangalore and is signed by their respective authorized representatives under their respective seal of office on the day of , 2017.

TO APPROVE FIXATION OF PAY AND ISSUE OF ORDERS TO THE ASSISTANT PROFESSORS WHO WERE AWARDED PROMOTION FROM STAGE I TO II AND STAGE II TO III UNDER UGC'S CAREER ADVANCEMENT SCHEME

The duly constituted Screening Cum Evaluation Committee had awarded promotion to Assistant Professors from Stage I to II and Stage II to III under CAS scheme of the UGC.

The same was placed as an item in the 120th meeting of the Executive Council held on 23.02.2016 and it is resolved vide resolution No. 2016.120.69 to approve the Minutes of the Screening Committee (copy enclosed).

Accordingly, based on the approval and the legal opinion dated 04.03.2016 obtained from Shri P.S. Raman, senior advocate through the University Counsel, office orders were issued on 04.03.2016 to 95 Assistant Professors promoting them from stage I to II and to 32 Assistant Professors from Stage II to III, subject to outcome of the WP. No. 6481 of 2016 and W.P. No. 6492 of 2016 filed in the Hon'ble High Court of Madras (copy enclosed).

Office orders were issued to the concerned faculty members, the pay fixation of the promotees is yet to be issued.

Subsequently, the matter was again placed as an item in the 124th Meeting of the Executive Council held on 16.02.2017 and it was resolved vide resolution No.2017.124.75 (copy enclosed) to refer to the next Executive Council after getting legal opinion and to approach the Hon'ble High Court of Madras to get exemption to this particular matter.

Shri P.S. Raman, Senior Advocate had already opined that the University may go ahead and implement the various resolutions passed in the Executive Council dated 23.02.2016 expressly stating that such implementation is subject to the outcome of the Writ Petition (copy enclosed).

Any promotion should be accompanied with the pay fixation (higher scale) which is a motivational factor to the employees for better output. Promotion without monetary benefit is not a career progression.

The CAS promotion orders for 127 faculty members was issued on 04.03.2016 and now it is 1 year and 4 months that they have not received the pay of the promoted scale. Besides, the arrears to be paid would be a huge financial burden to be adjusted in the Financial year 2016-17 and 2017-18.

Process has already been initiated for vacating the stay in the Hon'ble High Court of Madras by the University Counsel. Hence, it is placed before the Council for approval for issue of the pay fixation orders with a clause "subject to the outcome of the Writ Petition."

Once again the matter was listed on 29.02.2016 where again a prayer for an injunction restraining the implementation of the EC resolutions was refused.





MEMORANDUM OF UNDERSTANDING
BETWEEN
CLEVELAND STATE UNIVERSITY, CLEVELAND, OHIO, USA
AND
THE PONDICHERY UNIVERSITY,
KALAPET, PONDICHERY, INDIA



The faculties of Cleveland State University, Cleveland, Ohio, USA, (hereinafter referred to as "CSU"), and Pondicherry University, Kalapet, Puducherry, India, established under the Act of Parliament hereinafter referred to as "Pondicherry University", agree to establish this Memorandum of Understanding, hereafter referred to as "MOU", in order to promote international cooperation for the purposes of academic study and research.

I. Purpose of the MOU

Both parties agree to establish and encourage mutually beneficial educational and research-related activities that may result in the following types of cooperative programs:

- A. The development of reciprocal undergraduate student exchange programs;
- B. The facilitation of graduate student exchange for the purposes of research collaboration;
- C. The establishment of joint-degree programs;
- D. The exchange of academic personnel for the purpose of research, teaching and the delivery of special courses in their fields of specialization;
- E. The establishment of joint faculty-oriented research programs;
- F. Collaboration on third-party funded educational or economic assistance activities;
- G. The exchange of scientific and educational literature produced by either or both of the parties;
- H. The organization of conferences, seminars and symposia of mutual interest to the parties.
- I. The delivery of fee-based study abroad programs

II. Program Specific Agreements

The MOU is designed to facilitate development of mutually beneficial exchanges/programs and to promote research and academic relationship and should not be deemed to create legal and financial relationships between the parties.

Before any of the activities referenced above in Section I may be implemented, the parties shall negotiate details and resolve the issues involved therewith and enter into a separate Agreement pertaining to that activity ("Program Specific Agreement"). The term of such program Specific Agreement shall not extend beyond five (5) years in length.

Each such 'Program Specific Agreement' shall be subject to the availability of resources required to support the activity. In the event that the MOU Agreement is terminated by either of the parties, but financial commitments are stated and planned for in a Program Specific Agreement, the term of such agreements may not be beyond one (1) year in length from the MOU termination date.

III. Funding

The parties agree that each Program Specific Agreement activity undertaken pursuant to this MOU shall be dependent on the availability of funds and financial arrangements for each 'Program Specific Agreement' activity shall be negotiated and agreed to in writing prior to entering into a 'Program Specific Agreement' related thereto. The parties agree that they shall use reasonable efforts to find adequate financial resources for the activities and programs undertaken pursuant to this MOU.

IV. Terms

This MOU shall become effective upon signature by both parties and shall continue for a period of five (5) years unless terminated by either party by giving written notice at least 90 days in advance of the stated termination date, provided however, that termination of this MOU shall not affect activities already in progress pursuant to 'Program Specific Agreements', which shall continue until concluded by the parties in accordance with the terms of such Program Specific Agreements or as otherwise agreed to by the parties in writing. Both institutions agree to review this MOU periodically to evaluate the progress made in achieving mutual cooperation.

The faculties of Michigan State University, Michigan, USA, (hereinafter referred to as "MSU"), and Pondicherry University, Kalapet, Puducherry, India, established under the Act of Parliament, (hereinafter referred to as "Pondicherry University"), agree to establish this Memorandum of Understanding, hereafter referred to as "MOU", in order to promote international cooperation for the purposes of academic study and research.

I. Purpose of the MOU

Both parties agree to establish and encourage mutually beneficial educational and research-related activities that may result in the following types of cooperative programs:

- A. The development of reciprocal undergraduate student exchange programs;
- B. The facilitation of graduate student exchange for the purposes of research collaboration;
- C. The delivery of fee-based study abroad programs;
- D. The establishment of joint-degree programs;
- E. The exchange of academic personnel for the purpose of research, teaching and the delivery of special courses in their fields of specialization;
- F. The establishment of joint faculty-oriented research programs;
- G. Collaboration on third-party funded educational or economic assistance activities;
- H. The exchange of scientific and educational literature produced by either or both of the parties;
- I. The organization of conferences, seminars and symposia of mutual interest to the parties.

II. Program Specific Agreements

The MOU is designed to facilitate development of mutually beneficial exchanges/programs and to promote research and academic relationship, and should not be deemed to create legal and financial relationships between the parties.

Before any of the activities referenced above in Section I may be implemented, the parties shall negotiate details and resolve the issues involved therewith and enter into a separate Agreement pertaining to that activity ("Program Specific Agreement"). The term of such program Specific Agreement shall not extend beyond five (5) years in length.

Each such 'Program Specific Agreement' shall be subject to the availability of resources required to support the activity. In the event that the MOU Agreement is terminated by either of the parties, but financial commitments are stated and planned for in a Program Specific Agreement, the term of such agreements may not be beyond one (1) year in length from the MOU termination date.

III. Funding

The parties agree that each 'Program Specific Agreement' activity undertaken pursuant to this MOU shall be dependent on the availability of funds and financial arrangements for each Program Specific Agreement activity shall be negotiated and agreed to in writing prior to entering into a 'Program Specific Agreement' related thereto. The parties agree that they shall use reasonable efforts to find adequate financial resources for the activities and programs undertaken pursuant to this MOU.

IV. Terms

This MOU shall become effective upon signature by both parties and shall continue for a period of five (5) years unless terminated by either party by giving written notice at least 120 days in advance of the stated termination date, provided however, that termination of this MOU shall not affect activities already in progress pursuant to Program Specific Agreements, which shall continue until concluded by the parties in accordance with the terms of such 'Program Specific Agreements' or as otherwise agreed to by the parties in writing. Both institutions agree to review this MOU periodically to evaluate the progress made in achieving mutual cooperation.

V. Agreement Oversight Coordination

Each party shall designate a person or office to serve as liaison for implementing this Agreement. For Michigan State University, the primary contact person will be Dr. Karim M. **ADDENDUM CONCERNING STUDENT EXCHANGES
BETWEEN
THE UNIVERSITÉ LUMIÈRE LYON 2
AND
PONDICHERRY UNIVERSITY**

In order to promote the student exchange programme whose content has been established in the Cooperation Agreement between the Université Lumière Lyon 2 and Pondicherry University, both institutions have agreed to adhere to the following principles which will serve to regulate the aforementioned exchange programme:

1. Duration of the programme

The student exchanges will take place over either a semester or a full academic year.

2. Number of students benefitting from the exchange.

In principle, the number of students will not exceed 6 (*number*) in the course of an academic year. Each party will set itself the objective of maintaining reciprocity in the number of students benefitting from the exchange every year. Should such balance not be attained in a given academic year, adjustments will be made over a period of five (5) years. The number of students participating in the exchange will be calculated in semesters rather than in years.

3. Academic disciplines

For Pondicherry University : Bachelor's, Master's in all disciplines
For the Université Lumière Lyon 2: Bachelor's, Master's in all disciplines

4. Expenses

- (1) There will be reciprocal exoneration of tuition fees. The students taking part in the exchange programme will not be obliged to pay either tuition fees or any other obligatory expenses in the host university. They will nevertheless have to pay all the obligatory expenses owed to their university of origin.
- (2) The students taking part in the exchange programme will be responsible for their own national and international travel, accommodation and eating expenses, for acquiring all the text books and supplies, as well as all personal expenses. If students taking part in the programme are accompanied by their spouse or dependents, all expenses incurred by the spouse or dependents will be the sole responsibility of the student taking part in the exchange programme.

5. Selection

All students enrolling in undergraduate or postgraduate courses can apply for the exchange programme. The successful candidates will be selected by the university of origin on the basis of qualities such as knowledge of the language in which the courses are taught at the host university, adaptability, good academic dossier and good physical condition, as well as any other criteria the university of origin may wish to impose.

6. Registering at the host university

The students taking part in the exchange programme will take the standard classes associated with their field or, for one semester only, courses specially designed by the host

university. The students involved in the programme will enjoy the same rights and privileges as those from the host university with regard to the resources available in the context of the courses and all the associated services.

7. Assessment

When the programme reaches its end, the host university will be responsible for sending the university of origin all the grades obtained by the students. The university of origin will award credits on the basis of the assessment sent by the host university, in accordance with its own grading system and assessment policy.

8. Accommodation

The host university will assist and support the students taking part in the exchange programme in their search for appropriate accommodation.

9. Health insurance

Students who come to the Université Lumière Lyon 2 will be obliged to pay the student social security contributions that are obligatory for all students enrolling in a French university. This health insurance will cover their entire period of study in France.

9. Emergencies

In case of emergency, both universities will consult each other in order to determine the appropriate attitude to adopt.

This Memorandum will come into force on the date of its signature. It may be amended at any time after consultation and agreement of either the signatories whose names figure below or their representatives/successors.



To ratify the sanction of extraordinary leave to Dr. P. Kesava Kumar, Assistant Professor, Department of Philosophy of this University for a period of two years w.e.f. 21.01.2015 to 20.01.2017 so as to join the post of Professor in the Department of Philosophy at University of Delhi.

Resolved to ratify.

4.4 Half-pay Leave

Half-pay leave admissible to a permanent teacher shall be 20 days for each completed year of service. Such leave may be granted on the basis of medical certificate from a registered medical practitioner, for private affairs or for academic purposes.

Explanation:

A "completed year of service" means continuous service of specified duration under the university and includes periods of absence from duty as well as leave including extraordinary leave.

4.5 Commuted Leave

Commuted leave, not exceeding half the amount of half pay leave due, may be granted on the basis of medical certificate from a registered medical practitioner to a permanent teacher subject to the following conditions:

- (i) Commuted leave during the entire service shall be limited to a maximum of 240 days;
- (ii) When commuted leave is granted, twice the amount of such leave shall be debited against the half-pay leave due; and
- (iii) The total duration of earned leave and commuted leave taken in conjunction shall not exceed 240 days at a time. *Provided* that no commuted leave shall be granted under these rules unless the authority competent to sanction leave has reason to believe that the teacher will return to duty on its expiry.

Extraordinary Leave

- i) A permanent teacher may be granted extraordinary leave when:
 - (a) No other leave is admissible; or
 - (b) Other leave is admissible and the teacher applies in writing for the grant of extraordinary leave.

Extraordinary leave shall always be without pay and allowances. Extraordinary leave shall not count for increment except in the following cases:

- (a) Leave taken on the basis of medical certificates;

- (b) Cases where the Vice Chancellor/Principal is satisfied that the leave was taken due to causes beyond the control of the

teacher, such as inability to join or rejoin duty due to civil commotion or a natural calamity, provided the teacher has no other kind of leave to his credit;

- (c) Leave taken for pursuing higher studies; and
 - (d) Leave granted to accept an invitation to a teaching post or fellowship or research-cum-teaching post or on assignment for technical or academic work of importance.
- (iii) Extraordinary leave may be combined with any other leave except casual leave and special casual leave, provided that the total period of continuous absence from duty on leave (including periods of vacation when such vacation is taken in conjunction with leave) shall not exceed three years except in cases where leave is taken on medical certificate. The total period of absence from duty shall in no case exceed five years in the full working life of the individual.
- (iv) The authority empowered to grant leave may commute retrospectively periods of absence without leave into extraordinary leave.

8.4.7 Leave Not Due

- (i) Leave not due, may, at the discretion of the Vice Chancellor/Principal, be granted to a permanent teacher for a period not exceeding 360 days during the entire period of service, out of which not more than 90 days at a time and 180 days in all may be otherwise than on medical certificate. Such leave shall be debited against the half-pay leave earned by him/her subsequently.
- (ii) 'Leave not due' shall not be granted, unless the Vice Chancellor/Principal is satisfied that as far as can reasonably be foreseen, the teacher will return to duty on the expiry of the leave and earn the leave granted.
- (ii) A teacher to whom 'leave not due' is granted shall not be permitted to tender his/her resignation from service so long as the debit balance in his/her leave account is not wiped off while in active service, or he/she refunds the amount paid to him/her pay and allowances for the period not so earned. In a case where retirement is unavoidable on account of reason of health, incapacitating the teacher for further service, refund of leave salary for the period of leave still to be earned may be waived by the Executive Council.

4. Original Authenticated hologram
5. Anticopy
6. Hot stamping process
7. Double Ghost
8. QR code
9. Pictograph
10. Fusion Screen
11. Currency strip
12. Invisible printing

The University followed usual purchase procedures and norms for printing the new Degree Certificates with more security features. Orders were placed with M/s. Manipal Technologies Limited to print 35,000 numbers of Degree Certificates with above security features for both Regular exam and DDE Exam. Specimen degree certificate is enclosed.

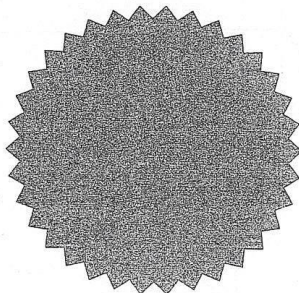

After submitting the present agreement to the competent authorities according to the regulations in force in each of the countries concerned, the two parties hereby agree on the following:

ARTICLE 1 :

The two universities decide to enter into a reciprocal exchange program of cooperation and coordination in academic teaching and research.

ARTICLE 2 :

The partners will identify the areas of common interest and will define the projects they wish to develop together, in conformity with the law in force in each of the countries and within the limits determined by a common agreement.

Those projects may include the following activities:

- a) The exchange of teachers and researchers
- b) The exchange of students
- c) The exchange of academic articles
- d) The development of common research projects
- e) The common direction of PhDs and dissertations
- f) The writing of common academic articles

The collaboration will be in the following area(s): Law, political science, international relations

This stage will be placed under the responsibility of the following bodies:

- For the University Paris 13 : **UFR de Droit, sciences politiques et sociales (DSPS)**
- For the partner : **Department of Politics and International Studies and Centre for European Studies**

This collaboration can be extended to other fields or activities by simple amendment.

ARTICLE 3 :

As far as the laws and regulations pertaining in each of the countries and their material possibilities allow, both parties agree to exchange academic staff to teach or lecture or to participate in research activities.

The staff members qualified to supervise theses at the University Paris 13 and at Pondicherry University may be associated in thesis's supervision in the other university, on signing a specific convention.

The contracting institutions may award the student:

- either a joint Ph.D. diploma
- or a Ph. D. diploma issued by each institution

In the case of a joint diploma, the approval of both the Research Committee and the Administrative council of the University Paris 13 is requested.

ARTICLE 4 :

The academic staff involved in exchanges, regulated by this present agreement, will continue to receive their salaries paid by their respective university and enjoy all the rights attached to their activity, as far as the laws and regulations pertaining in each country allow.

ARTICLE 5 :

Both parties agree to inform the other and exchange documents resulting from their respective activities in the area covered by Article 2 (publications, books, teaching experience, bibliographies, and exchanges of thesis...).

ARTICLE 6 :

Both contracting parties will confer whenever they deem necessary and will, in particular evaluate the development of teaching and research actions and make a report of those actions accomplished or in the process of being accomplished.

This report will be submitted to the competent authorities of both universities at the end of every three-year period.

Each cooperation programme will be subject to a specific agreement in which the obligations and the responsibilities of both parties will be spelt out in detail, including the terms and conditions presiding over the programmed activities.

ARTICLE 7 :

Both contracting parties will strive to favour common research programs.

ARTICLE 8 :

If any new knowledge were discovered together by the staff of the two partners (insofar as none of the two partners could reasonably claim the full propriety) within the framework of the implementation of the present agreement, this new knowledge will be the common propriety, equally allocated/shared between the two parties, unless they decide it in another way.

The two partners reserve the right to make together the most of this new knowledge and that in conformity with the law and regulations in force in each of the countries.

Both contracting parties reserve the right to explore jointly the scientific information and results obtained through the programs carried out by virtue of this agreement, respecting the laws and regulations pertaining in each country and the regulations governing both universities.

In view to this, the contracting parties will collaborate in publishing in national or international academic journals. Any unpublished information or results obtained conjointly may not be divulged to any third party, unless there is prior agreement between the two contracting parties.

Each of the partners keeps the full propriety on its previous knowledge and on the new knowledge gotten on their own.

Should the case arise, specific agreements concerning intellectual propriety of the researches and its exploitation, will have to be signed.

ARTICLE 9 :

The University Paris 13 and Pondicherry University will, within the limit of the laws and regulations pertaining in each country and as far as their means and student intake capacity will allow, promote the exchange of students who will be integrated into the regular curricular studies and the schools of research in the receiving universities. If the case arises and unless contrary regulations apply, the visiting students, by virtue of this present agreement, will continue to receive their scholarship or loan given by the national, local or regional authority to attend their original university. The students participating in these exchanges will pay fees in their university of origin only.

ARTICLE 10 :

The exchange students will pay the tuition fees in their university of origin. Both contracting parties will assume their own expenses for coordination and travels. The exchange teachers or students will be insured against risks (accident, disease, civil responsibility) and against an eventual repatriation they could incur during their stay in the receiving university.

ARTICLE 11 :

Both contracting parties will do their utmost to insure that the courses attended in the receiving university by visiting students, as provided by the above, may be integrated as a recognized part of the curriculum leading to the awarding of a degree or diploma from their university of origin. A pedagogic agreement has to be accorded between the two partners previously to any exchange students.

ARTICLE 12 :

Every project or activity provided by a separate agreement implementing the present agreement will be funded separately according to the resources available. Those resources necessary to the implementation of any project or activity will be negotiated by the coordinators with the persons they will consider adequate. Furthermore, regarding the resources available, the partners will have the possibility to develop activities funded by their own resources.

Both contracting parties will endeavour to fund from their own budget the means necessary to carry out the programme of cooperation and, if possible, will apply for such means to competent bodies within these exchanges.

ARTICLE 13 :

This agreement may be terminated wholly or on one of its amendments by either party by registered letter with acknowledgment of receipt, sent to the other partner, with a 6-month prior notice.

However, the parties commit themselves to achieving the undertaken activities, prior to the agreement termination.

In any event, the enrolled students' rights should be protected without prejudice to ongoing actions. In this case, termination will take effect at the end of the exam period after the meeting of the corresponding board of examiners. The terminating party, shall give written notice to the other party 60 (sixty) days before the aforesaid exam period.

However, failure to implement the agreement motivated by the safeguarding of the public interest or as the result of any instance of force majeure as commonly defined by law, the agreement shall be suspended as of right. In these circumstances, both parties are to fulfill again their mutual obligations once the factor responsible for the suspension has disappeared.

Nevertheless, if the suspension lasts longer than 15 (fifteen) days, the parties will expressly accept to meet in order to find a solution and/or agree on an appropriate agreement as a result of this suspension.

If no agreement is reached within 30 (thirty) days after this meeting, the agreement shall be automatically terminated provided that the rights for the students, pursuing their studies, remain protected without prejudice to ongoing actions.

ARTICLE 14 :

Both parties will try to reach an amicable solution within sixty (60) days of receiving a written settlement request for any disagreement relating to the present protocol of cooperation. When no amicable solution can be reached, the disagreement will be submitted to mediation and failing this to the arbitration tribunal of Paris (CMAP), to which both parties have agreed to adhere. The disagreement will then be settled by three judges.

ARTICLE 15 :

Both contracting parties guarantee each other against any legal action from the staff, suppliers and service providers for whom the other party is personally responsible under the mutual obligations defined in this convention

ARTICLE 16 :

The execution of the present agreement is subject to an annual report which the coordinators present to their respective universities. The coordinators are appointed by each university among the academic teaching or research staff. They are appointed for three years and may be reappointed thereafter.

ARTICLE 17 :

The articles of the present agreement may be amended or modified by mutual consent.

ARTICLE 18 :

The present agreement, which takes force upon its signature by the representative of the two parties, is concluded for a period of four years subject to termination at 6 (six) months' notice, without prejudice to outstanding actions. In case of renewal, the same procedure of submission to the competent national authorities is to be followed again.

As per Office Memorandum issued by the Ministry of Personnel, Public Grievances & Pensions, Dept. of Personnel & Training, Govt. of India (Vide O.M. No.280201/1/2010-Estt.(C) dated 08-04-2016) on LIEN which states that Lien represents the right of a Govt. employee to hold a regular post, whether permanent or temporary either immediately or on the termination of the period of absence.

Accordingly, the University has granted lien for a period of one year and relieved him from the University with effect from 01-06-2017 Vide Office Order No.38 (Ref. No.PU/ESTT/NT2/2017-18/42) dated 01-06-2017 with the following conditions:-

- 1) His lien in the post of Assistant, Pondicherry University shall be retained for a period of one year **w.e.f. 01-06-2017 A.N.** subject to ratification by the Executive Council.

- 2) Service rights in the post of Assistant in Pondicherry University shall be protected during the lien period only if the liability towards Leave Salary and Pension Contribution is borne either by the foreign employer or by the employee.
- 3) At the end of the lien period Shri K. Chinnadurai, Assistant has to either resign the post of Assistant in Pondicherry University or he should revert to his substantive post in this University
- 4) This University will not protect the pay drawn by Shri K. Chinnadurai under the foreign employer in case of reversion to this University at a later date.
- 5) Dues, if any, shall be adjusted against terminal benefits payable to him

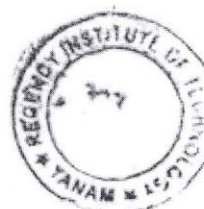

With reference to the subject cited above and further to our letter dated: 14.03.2017, we bring to your kind notice that the Scrutiny Committee and Re-Scrutiny Committee of All India Council for Technical Education (AICTE) during the review held on 03.03.2017 and 16.03.2017 respectively at AICTE Regional Office, Chennai, pointed out the deficiencies and instructed us to submit the No Objection Certificate in the Format-5 (Ref.APH 2017-18) of AICTE, obtained from the Pondicherry University for Progressive Closure of our Institution within a week for consideration of our application.
