TO RATIFY THE RE-EMPLOYMENT OF SHRI. B. R BABU AS REGISTRAR ON CONTRACTUAL BASIS W.E.F 01.09.2017 FOR A PERIOD TILL HE ATTAINS THE AGE OF 62 YEARS OR UNTIL FURTHER ORDERS, WHICHEVER IS EARLIER, IN ACCORDANCE WITH THE LETTERS OF MHRD VIDE LETTER NO.F-NO.39-3/2016-DESK U, DATED 13.06.2017 AND LETTER NO. F-NO.39-3/2016-CU -I DATED 28.08.2017 AND ORDINANCE NO 1, PART III, CLAUSE (9) (II) & (III) OF THE ADMINSITRATIVE ORDIANCES OF THE PONDICHERRY UNIVERSITY

Shri. B.R Babu, IAS (AGMU:2002) joined the University as Registrar in the Afternoon of 14.07.2017 as per the relieving order issued by the Chief Secretary, Government of Puducherry, by the order of the Lieutenant Governor, Government of Puducherry vide G. O MS No.49 dated 14.07.2017 (Enclosure-I). The said order states that as follows:

- 1. Consequent to the appointment of Shri. B.R Babu, IAS (AUGMU:2002), Secretary to Government, Puducherry, as Registrar, Pondicherry University, vide order read above (i.e. Letter of Ministry of Home Affairs, Government of India in letter no. F. No.14023/23/2013.UTS-I, dated 11.07.2017 (Enclosure-II) he is relieved from the Administration on the A N of 14.07.2017 to take up his new assignment as Registrar in Pondicherry University on deputation basis till the date of his superannuation on 31.08.2017.
- 2. Since the retirement age of Registrar in Pondicherry University is 62 years, the continuation of his service of B. R Babu, as Registrar, Pondicherry University after retirement on 31.08.2017, i.e from 01.09.2017 to 31.08.2019 will be regulated as per the rules of the University."

Subsequently, the Under Secretary to Government Puducherry issued another order (G O MS no.55) dated 30.08.2017 (Enclosure-III), by the order of the Lieutenant Governor, Government of Puducherry which states as follows:

3. "On attaining the age of superannuation Shri B. R Babu, IAS, (AGMU;2002), Secretary to Government, Puducherry presently on deputation to Pondicherry University as Registrar shall retire from service on the afternoon of 31.08.2017."

Earlier, the Ministry of Human Resources Development, Government of India has stated in its letter no. F.No.39-3/20169-Desk U, dated 13.06.2017, as follows:

- 4. "In the instant case the University proposes to appoint Shri B. R Babu, IAS (AGMU: 2000), Secretary to Government, Government of Puducherry as Registrar of the University on deputation basis. This Ministry has no objection to the proposed appointment. However as per AIS rules, a member of IAS shall retire from services on attaining the age of superannuation of 60 years. As such Shri B. R Babu, IAS, whose date of birth is 15.08.1957, shall retire from service on 31.08.2017 (A.N). Therefore his appointment as the Registrar of the University, with the approval of the Competent Authority of the University, can be treated as on deputation basis only till 31.08.2017.
- 5. Further, University may see, under the rules of the University, whether Shri Babu can continue as Registrar on contractual basis till he attains the age of 62 years. If so, Shri Babu may be appointed as Registrar for a period till he attains the age of 62 years or until further orders, whichever is earlier."

Since all the communications received by the University has stated that the appointment of Shri. B. R. Babu as Registrar of the University is on deputation basis till 31.08.2017 only and the same need to be approved by the Competent Authority of the University, the University has placed an agenda (Agenda no.2017.126.145, (Enclosure-IV)) to the Executive Council, the Competent Authority of the University for approval, in its 126th meeting held on 31.08.2017. The agenda also spelled out about the further engagement of Shri. B. R. Babu as Registrar as per the letter of the MHRD, vide its letter no. F.No.39-3/20169-Desk U, dated 13.06.2017 i.e on contractual basis from 01.09.2017 for a period till he attains the age of 62 years or until further orders, whichever is earlier.

The Competent Authority of the Pondicherry University, the Executive Council deliberated this agenda in its 126th meeting and unanimously resolved to relieve Shri B. R. Babu, IAS from the post of Registrar of the University with effect from the fore noon of 31.08.2017 to join his parent organization so as to enable him to avail his pension benefits. Further, the Competent Authority, the Executive Council resolved to appoint Prof. C. K. Ramaiah, one of the Executive Council

member and the Dean, School of Media and Communication, Pondicherry University as Registrar (i/c) with immediate effect until further orders. (Enclosure-V)

As per the decision of the Competent Authority of the Pondicherry University, the Executive Council, Shri B. R Babu, IAS, Registrar on Deputation basis was relieved in the fore noon of 31.08.2017 vide office order no. 85 (PU/ESTT/NT/2017-18/143) dated 31.08.2017. (Enclosure-VI)

However, Shri B. R Babu, IAS refused to hand over the charge to Prof. C. K. Ramaiah Registrar (i/c) and stayed in his office until midnight of 31.08.2017. As per the advice of the MHRD, Shri B. R Babu was reemployed as Registrar, on contractual basis, from 01.09.2017 for a period till he attains the age of 62 years or until further orders, whichever is earlier vide office order no 86 (PU/ESTT/NT10/2017-18/144), dated 31.08.2017. (Enclosure-VII)

All the communication from MHA, MHRD and Government of Puducherry state that his further engagement in post of Registrar is to be governed by the Rules of the University. In the instant case the Rules regarding the reemployment of any administrative officer, including the Registrar beyond the age of superannuation is set out in Ordinance no 1, Part iii, Clause (9) (ii) & (iii) of the Administrative Ordinance of the Pondicherry University. The Administrative Ordinance states that:

- 6. Clause (9) (ii) states that the Executive Council has the power to reemploy persons who have worked under the Central Government or State Government or Union Territory Government or other Universities and who have retired from service on superannuation or on other grounds except on invalid grounds.
- 7. Clause (9) (iii) further states that the over-riding consideration by the Executive council for grant of extension/re-employment is that it must be in the interest of the University and in addition satisfy one of the following two conditions:
 - a. That no suitable person could be made available from the lower cadre on promotion or there is shortage in that cadre;

b. That the retiring officer is of outstanding merit.

Therefore it placed before the Executive Council for ratification of the reemployment of Shri B. R Babu as Registrar, on contractual basis, from 01.09.2017 for a period till he attains the age of 62 years or until further orders as per the office order no.86 (PU/ESTT/NT10/2017-18/144) dated 31.08.2017 which was issued as per the Section 13 (3) of the Pondicherry University Act, 1985 (Enclosure-VIII).

THE REGISTRAR

- (2) The Registrar shall have the power to enter into agreements, sign documents and authenticate records on behalf of the University and shall exercise such other powers and perform such other duties as may be prescribed by the Statutes.
- 17 The Finance Officer shall be appointed in such manner and shall exercise such powers and perform such duties as may be prescribed by the Statutes.

THE FINANCE OFFICER

18 The manner of appointment and powers and duties of other officers of the University shall be prescribed by the Statutes.

OTHER OFFICERS

19 The following shall be the authorities of the University:-

AUTHORITIES OF THE UNIVERSITY

- (1) The Court;
- (2) The Executive Council;
- (3) The Academic Council;
- (4) The Boards of Schools;
- (5) The Planning Board; and
- (6) Such other authorities as may be declared by the Statutes to be authorities of the University.

- (d) The Director of Physical Education, Sports, National Service and Student Welfare shall co-ordinate the activities of the University in respect of physical education, sports, national service and student welfare and other activities that involve student participation in community development.
- (e) The Director of Physical Education, Sports, National Service and Student Welfare shall have such other powers and perform such other functions in his field as may be determined or delegated to him by the Executive Council and the Vice-Chancellor.

REGISTRAR

- 4 (1) The Registrar shall be a whole-time salaried officer of the University.
 - (2) The emoluments and other terms and conditions of service of the Registrar shall be such as may be prescribed by the Ordinances:
 - * Provided that the Registrar shall retire on attaining the age of sixty two years:
 - (3) When the office of the Registrar is vacant or when the Registrar is, by reason of illness, absence, or any other cause, unable to perform the duties of his office, the duties of the office shall be performed by such person as the Vice-Chancellor may appoint for the purpose.
 - (4) (a) The Registrar shall have power to take disciplinary action against such of the employees, excluding teachers and academic staff, as may be specified in the orders of the Executive Council and to suspend them pending inquiry, to administer warnings to them or to impose on them the penalty of the censure of the withholding of increment:

Provided that no such penalty shall be imposed unless the person concerned has been given a reasonable opportunity of showing cause against the action proposed to be taken in regard to him.

- (b) An appeal shall lie to the Vice-Chancellor against any order of the Registrar imposing any of the penalties specified in sub-clause (a).
- (c) In a case where the inquiry discloses that a punishment beyond the powers of the Registrar is called for, the Registrar shall, upon conclusion of the inquiry, make a report to the Vice-Chancellor along with his recommendations:

Provided that an appeal shall lie to the Executive Council against an order of the Vice-Chancellor imposing any penalty.

- (5) The Registrar shall be ex-officio Secretary of the Executive Council, the Academic Council and the Boards of Schools, but shall not be deemed to be a member of any of these authorities. He shall be ex-officio Member-Secretary of the Court
- (6) It shall be the duty of the Registrar,
 - to be the custodian of the records, the common seal and such other property of the University as the Executive Council shall commit to his charge;
 - (b) to issue all notices convening meeting of the Court, the Executive Council, the Academic Council, the Boards of Schools, the Boards of Studies, the Boards of Examiners and of any committees appointed by the authorities of the University;
 - to keep the minutes of all the meetings of the Court, the Executive Council, the Academic Council, the Boards of Schools, and of any committees appointed by the authorities of the University;
 - (d) to conduct the official correspondence of the Court, the Executive Council and the Academic Council;
 - * to arrange for and superintend the examinations of the University in a accordance with the manner prescribed by the Ordinances.
 - (f) to supply to the Visitor, Copies of the agenda of the meetings of the authorities of the University as soon as they are issued; and the minutes of such meetings;
 - (g) to represent the University in suits or proceedings by or against the University, sign powers of attorney and verify pleadings or depute his representative for the purpose; and
 - (h) to perform such other duties as may be specified in the Statutes, the Ordinances or the Regulations or as may be required, from time to time, by the Executive Council or the Vice-Chancellor.

EMOLUMENTS, TERMS AND CONDITIONS OF SE OF THE REGISTRAR, under Statute 4(2)

4 (1) (A)

1. The Registrar shall be a whole-time salaried officer of the University and he/she shall receive pay behides allowances as admissible to the University staff, in the scale of pay of Rs.16400-450-20900-500-22400 or as revised from time to time by the Executive Council. His/her appointment shall be for a term of five years and it may be renewed for similar terms.

Provided that in the event of the Office of the Registrar being filled by obtaining the services of a person on deputation / absorption, the salary and other service conditions shall be such as may be admissible to him according to the terms and conditions finalized in consultation with the parent Organisation.

- 2. Registrar shall perform his/her functions and duties as laid down in the Statutes and Ordinances.
- 3. Registrar shall be provided with unfurnished University accommodation for which he/she shall pay rent at the usual rate.
- 4. Other conditions of service of the Registrar shall be as provided in the "Contract of Service of Officers" (enclosed) and approved by the Executive Council, subject to such other additional conditions as may be specified by the Executive Council.
- 5. The contract of service, of the Registrar shall be signed, on behalf of the University, by the Officer performing the duties of the Registrar at that time or by the Finance Officer of the University.

Form of Contract of Service for Officers Memorandum of Agreement made this the day of between(hereinafter called the 'Officer') of the first part, and the Pondicherry University being a body corporate constituted under the Pondicherry University Act, 1985 (No. 53 of 1985) (hereinafter called the 'University') of the second part. It is hereby agreed as follows: 1. That the University hereby appoints to be an officer of the University with effect from the and the said, hereby accepts the engagement and undertakes to take such part in the activities of the University and perform such duties in the University as may be required by and in accordance with the said Act, Statutes and Ordinances framed there under, for the time being in force. 2. The officers pay will be fixed in the scale of Rs. accordance with rules applicable for the University employees and he/she/she will be eligible for normal increments as applicable in the rule. 3. That the said shall be a whole time Officer of the University and unless the contract is terminated by the Executive Council or by the Officer before the expiry of the term of his/her/her appointment for which he/she/she is appointed or is terminated as hereinafter provided, shall continue in the service of the University for the period of his/her

4. That the said Officer agrees to be bound by the Statutes, Ordinances, Regulations and Rules for the time being in force in the University, provided that no change in the terms and conditions of service of Officer shall be made after his/her/her appointment in regard to designation, scale of pay, increment and provident fund so as to adversely affect him/her.

- 5. That the Officer shall devote his/her/her whole time to the service of the University and shall not, without the written permission of the University, engage directly or indirectly, in an trade or business whatsoever, or other work to which any emolument or honorarium is attached.
- 6. It is further agreed that his/her/her engagement shall not be liable to be terminated befor the expiry of the aforesaid period of appointment by the University except on the ground o misconduct as laid down in Statute 27 of the Statutes of the University.
- 7. Any dispute arising out of this contract shall be settled in accordance with the claus (2), of Section 31 (reproduced below):

"Any dispute arising out of a contract between the University and any employee shall at the request the employee, be referred to a Tribunal of Arbitration consisting of one member

cappointed by the Executive Council, one member nominated by the employee concerned and an unity cappointed by the Visitor. The decision of the Tribunal shall be final, and no suit shall lie in any Civil Court in respect of the matters decided by the Tribunal. Every such request shall be deemed to be a submission to arbitration upon the terms of this section within the meaning of the Arbitration Act, 1940".

- 8. The Officer may, at any time, terminate his/her/her engagement by giving the Executive Council three months' notice in writing, provided that the Executive Council may waive the requirement of notice at its discretion.
 - 9. On the termination of this engagement, from whatever cause, he/she shall handover to University all records and such other articles belonging to the University as may be due from invher.

TO RATIFY THE RELIEVING OF SHRI. B. R BABU FROM HIS DUTIES AS REGISTRAR ON CONTRACTUAL BASIS W.E.F THE F.N. CONSEQUENT TO **FILING** OF FIR BYTHECORRUPTION BUREAU (ACB) OF THE CENTRAL BUREAU OF INVESTIGATION (CBI) ON SHRI. B. R BABU, DURING HIS SERVICE WITH THE GOVERNMENT OF PUDUCHERRY, AS ITS SECRETARY TO GOVERNMENT (HEALTH) IN RELATION TO A CASE WHERE HE ALONG WITH OTHER OFFICIALS OF THE GOVERNMENT PUDUCHERRY HAVE ENTERED INTO A CRIMINAL CONSPIRACY WITH THE MANAGEMENT OF MANY PRIVATE MEDICAL COLLEGES IN THE MATTER OF ADMISSION OF STUDENTS IN THE PG MEDICAL COURSES IN PUDUCHERRY AND IN FURTHERANCE CRIMINAL CONSPIRACY, THE ACCUSED OFFICIALS ABUSED THEIR OFFICIAL POSITION AND CHEATED THE BONAFIDE STUDENTS WHO WERE ISSUED WITH PROVISIONAL ADMISSION CERTIFICATE BY CENTRAL ADMISSION **COMMITTEE** (CENTAC) APPOINTMENT OF PROF. K. THARANIKARASU, PROFESSOR & HOD, DEPARTMENT OF CHEMISTRY & CONTROLLER OF EXAMINATIONS (I/C) AS REGISTRAR (I/C) W.E.F FROM THE F.N. OF 21.09.2017 IN ACCORDANCE WITH CLAUSE 4(3) OF THE STATUTES OF THE PONDICHERRY UNIVERSITY ACT, 1985

On 20.09.2017, it has come to the notice of the Chairperson of the Executive Council through WhatsApp (posted by the Lt. Governor to the members of the WhatsApp group and the Vice Chancellor is also a member) about the filing of First Information Report by the Anti Corruption Bureau of the Central Bureau of Investigation (CBI) on certain officials of Government of Puducherry, including Shri. B. R Babu, the then Secretary to Government (Health) in connection with a case where these officials have entered into a criminal conspiracy with the management of many private medical colleges in the matter of admission of students in the PG Medical courses in Puducherry and in furtherance of the criminal conspiracy, the accused officials abused their official position and cheated the bona-fide students who were issued with provisional admission certificate by Central Admission Committee (CENTAC).

The FIR No. RC MAI 2017 A 0020 dated 18.09.2017 (Enclosure-I) has named Shri B. R Babu, IAS the then Secretary to Government of Puducherry (Health) who has been re-employed as Registrar of the Pondicherry University, on

contractual basis after his superannuation on 31.8.2017 and contract basis with effect from 01.09.2017 vide Office Order No. 86 (PU/ESTT/NT10/2017-18/144) dated 31.08.2017, as accused No 3.

The FIR states that "it is evident that Accused 1 to Accused 6 (wherein Shri B. R Babu is Accused 3) and other unknown public servants abused their official position in pursuance of a criminal conspiracy entered with Accused 7 to Accused 13 and facilitated the private medical colleges to admit students for the PG courses even though, they were not sponsored by CENTAC which resulted in frustrating genuine students losing opportunity to continue higher education and ineligible students admitted."

The FIR further states that "thereby Accused 1 to Accused 13 (wherein Shri B. R Babu is Accused 3) conspired together during the year 2017 in furtherance of that they have cheated the bona-fide students in the matter of admissions in PG courses in the UT of Puducherry by giving admissions to ineligible candidates for collecting exorbitant admission fee etc. Public servants 1 to Accused 6 (wherein Shri B. R Babu is Accused 3) failed to exercise that proper admission procedures and facilitated the management of the Medical colleges by abusing their official position."

Further, the FIR concludes that "the above acts of Accused 1 to Accused 6 (wherein Shri B. R Babu is Accused 3) prima facie constitutes commission of cognizable offence punishable U/s 120-B r/w 420 IPC and Sec.132 (2) r/w Sec.13 (1)(d) of the Prevent of corruption Act, 1988."

It is submitted that, the FIR on Shri B. R Babu is an outcome of 'failure to exercise that proper admission procedures and facilitated the management of the Medical colleges by abusing their official position' and 'abuse of their official position in pursuance of a criminal conspiracy entered with others to facilitate the private medical colleges to admit students for the PG courses even though, they were not sponsored by CENTAC which resulted in frustrating genuine

students losing opportunity to continue higher education and ineligible students admitted.'

Had the FIR been on any other act/acts of crime, the 'interest of the University' will not be at jeopardy and the University would have stuck to the golden maxim of criminal jurisprudence, 'every person accused of a crime is presumed to be innocent until proven guilty'.

But in the instant case, the Pondicherry University grants affiliation to all the colleges run in the U T of Puducherry, including the private medical colleges named in the above said FIR and given the acquaintance between the management of these private colleges and the continuance of Shri B. R Babu as Registrar can jeopardize interests of the University.

Further, the continuance of an accused in the CBI case related to admission of ineligible students to PG course without following the laid down procedures, in furtherance of a criminal conspiracy with private medical colleges may cause apprehension about the genuineness of admission process carried out in Pondicherry University, which will also put the interests of the University at stake.

Ordinance no 1, Part iii, Clause (9) (ii) & (iii) of the Administrative Ordinance of the Pondicherry University lays down the rules for re-employment of persons retired from service of Central Government or State Government or Union Territory Government or other Universities. The above provisions of the Administrative Ordinance states that:

- 1. The Executive Council has the power to re-employ persons who have worked under the Central Government or State Government or Union Territory Government or other Universities and who have retired from service on superannuation or on other grounds except on invalid grounds.
- 2. The over-riding consideration by the Executive council for grant of extension/re-employment is that it must be in the interest of the University and in addition satisfy one of the following two conditions:

a. That no suitable person could be made available from the lower cadre on promotion or there is shortage in that cadre;

Thus the over-riding consideration by the Executive council for grant of extension/re-employment is that it must be in the interest of the University, which itself *stands negated* in the case of the re-employment of Shri B. R Babu, as Registrar (on contractual basis), vide the office order number 86 (PU/ESTT/NT10/2017-18/144) dated 31.08.2017.

Therefore, Shri. B.R Babu has been relieved from the post of Registrar (reemployed on contract basis) with effect from the FN of 21.09.2017, in the interest of the University and Prof. K. Tharanikarasu, HOD, Department of Chemistry and Controller of Examinations (i/c) has been assigned with the additional charge of the duties of the Registrar with effect from the FN of 21.09.2017, until further orders, in accordance with Clause 4(3) of the Statutes of the Pondicherry University Act, 1985.

Hence it is placed before the Executive Council to ratify the relieving of Shri. B. R Babu, who has been re-employed as Registrar on contractual basis from the post of Registrar as per the office order no.92 (PU/Estt/NT10/2017-18/175) dated 21.09.2017 (Enclosure-II) and appointment of Prof. K. Tharanikarasu as Registrar (i/c) as per the office order no.93 (PU/ESTT/NT10/2017-18/177) dated 21.09.2017. (Enclosure-III)

A reliable information is received to the effect that Public servants A-1 to A-6, who are officials of Govt. of Puducherry and other unknown Public servants entered into a criminal conspiracy with A-7 to A-13, in Puducherry and other places during March-July 2017, in the matter of admission of students in the PG Medical courses in Puducherry, and in furtherance of the criminal conspiracy, the accused Public Servants abused their official position and cheated the bonafide students who were issued with provisional admission certificate during counseling by Central Admission Committee (CENTAC) denying them the seat which they were otherwise allocated after admission process and facilitated the Private Medical colleges to admit students who were not sponsored by CENTAC collecting exorbitant fees thereby depriving the genuine candidates.

The Ministry of Health, Government of India vide Circular V. No.11025/2016/MEP Dt.5-12-2016 and 21-2-2017 and later Vide Circular No. FFV/11011//1/2015-MEP (Pt) dated 10-3-2017, directed the Chief Secretaries of all the States and Union Territories, that it is mandatory to have common counseling for admission to UG and PG courses in all medical institutions in the State by the Government concerned and there shall be no exemption from common counseling and all institutions including private medical colleges and deemed universities shall be covered under it and counseling for admission in common courses should be organized by State/Central Government based on the marks obtained in National Eligibility Entrance Test. Accordingly, Govt. of Puducherry vide Order dt.25-2-2017, entrusted CENTAC with the work relating to the PG admission in Medical colleges in the UT of Puducherry.

Dr. V. Govindaraj, Convenor, CENTAC, Dr. K. Pajaniradja @ Kichena, Joint Convenor, CENTAC and Dr.M. Jonathan Daniel, Co-ordinator, CENTAC were the officials involved in counseling. Shri Narendra Kumar, IAS is the Chairman of CENTAC and also the Development Commissioner of Puducherry. Dr. Raman is the Director of Health and Family Welfare, Govt. of Puducherry and Dr. B.R. Babu is the Secretary (Health) of Govt. of Puducherry who were coordinators between the CENTAC and private medical colleges.

The Medical colleges in Puducherry have 318 Post Graduation/ Diploma seats in Medicines, of which 162 seats are earmarked as Govt. Quota seats and rest of 156 are earmarked as Management seats. For PG Medical admission, 267 candidates have applied against 162 Govt. Quota and 1827 candidates have applied against 156 Management quota seats. The process of counseling for 2017-18 was conducted by CENTAC (Centralised Admission Committee), under the guidance of Ministry of Health, Govt. of Puducherry.

The first phase of counseling was conducted by CENTAC (Centralised Admission Committee) on 4th and 11-5-2017 and the second phase of counseling was held on 19-5-2017. The counseling was conducted by Dr. V. Govindaraj, Convenor, CENTAC, Dr. K. Pajaniradja @ Kichena, Joint Convenor, CENTAC and Dr.M. Jonathan Daniel, Co-ordinator, CENTAC.A mop up counseling was held on 29-5-2017 and a final counseling was held on 31-5-2017. In pursuance of the criminal conspiracy, the first phase of counseling was held without even notification of fee, which was later intimated on 14-5-2017 ie. after completion of first phase of counseling. The Fee Committee appointed by Govt. of Puducherry was headed by Retired Justice Rajasekaran.

In furtherance of the criminal conspiracy, though CENTAC issued Provisional Admission Certificate, no efforts were made by A-1 to A-3 to verify the number of students who have not joined against the provisional admission certificate, and for the second round of counseling, the existing

vacancies due to refusal of the seven medical colleges (four deemed universities and three self financing colleges) to admit students even though the students are issued Provisional admission certificate by CENTAC, were not considered and while calculating the vacancy position, it was shown by CENTAC counseling authorities A- 4 to A-6 in the CENTAC web sites as if all the students who have issued with provisional admission certificate by CENTAC were admitted in the colleges.

In pursuance of the Criminal conspiracy, even though the fees committee issued a revised order on24-5-2017, increasing the fees substantially, which can be charged from Govt. quota and Management quota students in respect of three self financing colleges, all the three colleges have refused admission to bona fide students and instead admitted students who have not even sponsored by CENTAC, by taking huge fees that had been mentioned in the website of the medical colleges ranging from Rs 40 to 50 Lakhs.

Similarly, in respect of four deemed universities, even though the Division Bench of the Hon'ble High court of Madras vide order dt. 16-6-2017 in WP No.14232/2017 directed the Deemed Universities to admit students who were issued with provisional admission certificates by CENTAC, by taking a initial fee of Rs.10 lacs per student and allowed the deemed universities to collect the balance fee depending upon the fee structure to be decided by University Grants Commission, all the four deemed universities have refused admission to the bona fide students and instead admitted students who have not even sponsored by CENTAC, by taking huge Fees.

For the admission in the PG Medical course, bona fide students, who have applied to CENTAC and who were given provisional allotment in the above seven medical colleges by CENTAC were not admitted by the Private Medical colleges and it is reliably learnt that the candidates who have paid huge fees were admitted against the seats which were allotted to other bona

fide students by CENTAC, thereby depriving the eligible students their legitimate right to pursue their higher medical education, and further leaving their career at jeopardy.

Thus it is evident that A-1 to A-6 and other unknown public servants of Govt. of Puducherry, abused their official position in pursuance of the criminal conspiracy entered with A-7 to A-13 and facilitated the private medical colleges to admit students for the PG courses even though, they were not sponsored by CENTAC, which resulted in frustrating genuine students losing opportunity to continue higher education, and ineligible students admitted.

Thereby A-1 to A-13 conspired together during the year 2017 in furtherance of that they have cheated the bonafide students in the matter of admissions in PG courses in the UT of Puducherrry by giving admissions to ineligible candidates for collecting exorbitant admission fee etc. Public Servants A-1 to A-6 failed to exercise that proper admission procedures and facilitated the management of the Medical colleges by abusing their official position.

The above acts of A-1 to A-13 prima facie constitutes commission of cognizable offences punishable U/s 120-B r/w 420 IPC and Sec. 13(2) r/w Sec. 13(1)(d) of the P.C. Act, 1988 and hence this FIR.

Whereas Shri B. R Babu joined Pondicherry University as Registrar (on deputation basis) on the AN of 14.07.2017 and was serving as Registrar until the Fore Noon of 31.08.2017 and subsequently he was re-employed as Registrar on contractual basis with effect from 01.09.2017 FN vide Reference No.PU/Estt/NT10/2017-18/144 dated 31.08.2017cited above (Order no 86). Prior to joining the University he was working as Secretary to Government (Health), Government of Puducherry.

Whereas the Chief Rector of Pondicherry University and the Lieutenant Governor of Puducherry has forwarded a message to the Vice Chancellor through WhatsApp about filing of First Information Report by the Anti Corruption Bureau of the Central Bureau of Investigation (CBI) on Shri B. R Babu while he was serving the Government of Puducherry as Secretary to Government (Health).

Whereas, the FIR No. RC MAI 2017 A 0020 dated 18.09.2017 has named Shri B. R Babu, IAS the then Secretary to Government of Puducherry (Health) as accused no 3. The FIR states that it is evident that Accused 1 to Accused 6 (wherein Shri B. R Babu is Accused 3) and other unknown public servants abused their official position in pursuance of a criminal conspiracy entered with Accused 7 to Accused 13 and facilitated the private medical colleges to admit students for the PG courses even though, they were not sponsored by CENTAC which resulted in frustrating genuine students losing opportunity to continue higher education and ineligible students admitted.

Whereas, further the FIR states that thereby Accused 1 to Accused 13 (wherein Shri B. R Babu is Accused 3) conspired together during the year 2017 in furtherance of that they have cheated the bonafide students in the matter of admissions in PG courses in the UT of Puducherry by giving admissions to ineligible candidates for collecting exorbitant admission fee etc. Public servants 1 to Accused 6 (wherein Shri B. R Babu is Accused 3) failed to exercise that proper admission

procedure and facilitated the management of the Medical colleges by abusing their official position.

Whereas, further the FIR concludes that the above acts of Accused 1 to Accused 6 (wherein Shri B. R Babu is Accused 3) prima facie constitutes commission of cognizable offence punishable U/s 120-B r/w 420 IPC and Sec.132 (2) r/w Sec.13 (1)(d) of the Prevent of corruption Act, 1988.

Whereas, Pondicherry University grants affiliation to all the colleges run in the U T of Puducherry, including the private medical colleges named in the above said FIR and given the nexus between the management of these private colleges and Shri B. R Babu, the continuance of Shri B. R Babu as Registrar can jeopardize the interests of the University.

Whereas, Ordinance no 1, Part III, Clause (9) (ii) of Administrative Ordinance states that the Executive Council has the power to re-employ persons who have worked under the Central Government or State Government or Union Territory Government or other Universities and who have retired from service on superannuation or on other grounds except on invalid grounds. Further it also states that states that the over-riding consideration by the Executive Council for grant of extension/re-employment is that it must be in the interest of the University.

Whereas, the continuance of an accused by CBI in a case related to admission of ineligible students to PG course without following the laid down procedures, in furtherance of a criminal conspiracy with private medical colleges should not cause any apprehension about the genuineness of admission process carried out in Pondicherry University.

Therefore, Shri B. R Babu, the Registrar who has been re-employed on contractual basis is relieved form the post of Registrar immediately with effect from the FN of 21.09.2017.
