TO CONSIDER THE REQUEST FOR ELEVATION OF CENTRE FOR BIOINFORMATICS TO THE STATUS OF DEPARTMENT OF BIOINFORMATICS

A proposal for elevation of Centre for Bioinformatics to Department of Bioinformatics in the Pondicherry University has been submitted by Dr.A. Dinakara Rao, Centre Head, Centre for Bio Informatics and recommended by the Dean, School of Life Sciences. The School Board of Studies held on 27.03.2017 has recommended the elevation of the Centre to Department. Approval has been accorded by the Academic Council vide resolution No: 2019.81.07 dated 14.02.2019.

The following facts of the Centre for bioinformatics are submitted in this regard:

- The Centre offers UGC Innovative programme in M.Sc. Bioinformatics since 2007.
- The Centre offers a Network M.Tech. Computational Biology programme in collaboration with Anna University from 2010. Initially this program was M.Sc. Computational Biology and upgraded to M.Tech. program in 2014. Pondicherry University is the nodal agency for admissions for both Universities from 2010.
- > The Centre is offering Ph.D. programme from 2009 (9 years).
- There are 11 faculty members from different disciplines: 3 Professors, 2 Associate Professors (one vacant) and 7 Assistant Professors, trained technical staff and good infrastructure facility and considered one of the biggest Bioinformatics Centres in the country.
- The Centre is supported by UGC SAP (DRS level 1) for 2012-2017 and DST FIST for the period 2015-2019. The process of applying for UGC SAP (Level II) is in pipeline.
- The only Centre in the University was identified as Centre of Excellence from DEITY, Govt. of India (2008-2014).

- The Centre is funded by DBT with two ongoing schemes: DBT DIC Grant and DBT M.Tech. Computational Biology Grant.
- Faculty of the Centre have published more than 250 research papers in notable high impact factor journals. Some notable high impact factor journals are Nature Scientific Reports, Journal of the American Chemical Society, Plos-One etc.
- The Centre is recognized and rated top in Bioinformatics research in the country and awarded incentive award for three times for high impact research publications.
- One of the Faculty Dr. Archana Pan was awarded for best publication by DBT in the year 2016.
- One of our faculty Dr. S. Mohane Coumar is listed in the top 10 researchers in the University Vidwan Expert Database.
- The faculty has more than 25 research projects funded by DBT, DST, CSIR, UGC, DEITY in the last 10 years.
- > More than 400 students completed the PG programme from the Centre.
- > So far 38 Research Scholars were awarded Ph.D. in Bioinformatics
- The PG students and Research scholars of our Centre are placed in reputed Universities, Institutions and Industries.
- The Centre has a separate state of art building with 3 computer labs, wet lab, analytical lab, library, seminar hall and 13 individual faculty research labs.
- The Centre is maintaining a separate department library during last 15 years and more than 700 books are available in the library.
- The Centre has a separate website (<u>www.bicpu.edu.in</u>) for the past 12 years and all the activities related to teaching and research are updated regularly.
- More than 15 published online databases are developed in-house and are made available for all users from different parts of the world.
- The Centre has sophisticated well maintained wet lab equipments like Biacore 3000, HPLC, Gel Doc, Fluorescence Microscope including a Cell culture facility

- The Centre is having a high performance computing facility and there are 160 desktop computers and the whole building is under UPS power backup
- The Centre is vibrant in conducting national seminars/workshop/shotterm courses regularly and outreach programme as an extended activity like national science day celebration to school and college students for the past 7 years.

TO CONSIDER THE REQUEST OF CONTRACT STAFF FOR ADMISSION OF THEIR WARDS IN KENDRIYA VIDYALAYA NO. 2 UNDER SPONSORSHIP QUOTA (10 NOS. ALLOTTED FOR THE REGULAR EMPLOYEES OF THE UNIVERSITY)

Kendriya Vidyalaya No.2 established in 1986, situated within the Pondicherry University Campus caters to the educational needs of the wards of University employees from Class I to Class XII.

There is a constant demand for admission to Kendriya Vidyalaya No.2 from the University Community especially from the contract employees. In view of the overall development of the University and due to retirement of existing regular employees from service, staff have been engaged on contract basis on separate terms and conditions governing their employment They are eligible for Earned Leave, Maternity Leave & CPF, etc.

Considering the request made by the contract staff for admission of their wards in Kendriya Vidyalaya No.2, the wards of these staff may also be considered for admission against the earmarked 10 seats (sponsorship quota), subject to the conditions that seats are available after providing seats to the wards of regular employees of this University.

In this connection, letter has already been sent to the Commissioner, Kendriya Vidyalaya Sangathan, New Delhi requesting him to consider the wards of the contract staff against the earmarked sponsorship quota as mentioned above.

TO CONSIDER THE REVISION OF APPLICATION FEE FOR VARIOUS TEACHING & NON-TEACHING CATEGORIES UNDER DIRECT RECRUITMENT

The Executive council vide its resolution No. 2010.106.213 dated 29.11.2010 has considered the application fee and exemption from payment of application fee with a view to encourage the candidates.

Accordingly, the Women, SC, ST, PH and Ex-servicemen candidates have been exempted from payment of application fee till 2018.

However, due to various administrative reasons and also necessity of generating resources of our own, the University has approved the fee structure as follows in the recruitment notification dated 05.08.2019 for various faculty positions.

The Academic Fee Revision Committee under the Chairmanship of the Director, SEI&RR in the meeting held on 18.01.2019 has recommended for revision of fees for the existing courses to be implemented from the academic year 2019-20.

This was also approved by the Academic Council / Executive Council in this meeting held on 14.02.2019 & 15.02.2019 respectively and thereafter included in the University Prospectus 2019-20 and hosted in the University website.

Several representations were received from Students / Students' Council objecting to the fees hike. Hence, as per the direction of the Vice-Chancellor this was referred to the Academic Fees Revision Committee to look into the issue.

Accordingly, the Fees Revision Committee met on 22.05.2019 and prepared a revised fee structure (copy enclosed).

The salient points of recommendation are:

- The Committee found that the increase of fees in all courses except MBA, MCA and M.Sc. & M.Tech. programme in Computer Science are only nominal and did not recommend any revision.
- The Committee reduced the fees in all MBA (13%), MCA (29%), M.Sc. / M.Tech. Computer Science Programme (21%).
- 3. The Committee did not recommended any reduction of fees in respect of the Self-Financing, Part-Time Programmes and Ph.D. Programmes.

The recommendation of the Committee and the revised fee structure were also approved of the Vice-Chancellor. The revised fee structure was hosted in the University website and implemented.

- 3. Develop Short-term courses for college faculty.
- 4. To develop courses in Sri Aurobindo Studies on Distance and online modes in collaboration with DDE of Pondicherry University and disseminate them.
- 5. To develop soft-core courses which could be taken by students of the University.

And further it is informed that the Sri Aurobindo Centre for Advanced Research (SACAR) could be a partner institution for supporting in planning and execution of the programmes and activities of the Sri Aurobindo Chair.
