RECOGNITION TO CONSIDER THE  $\mathbf{OF}$ CERTAIN **PRIVATE** CLINICS/HOSPITALS IN PUDUCHERRY FOR TREATMENT OF **EMPLOYEES** OF PONDICHERRY UNIVERSITY AND THEIR **DEPENDENTS AND** REIMBURSEMENT OF **EXPENSES** ON TREATMENT TAKEN BY THEM

In order to facilitate the employees of Pondicherry University and their dependents, various private clinics/hospitals in Puducherry, has already been recognized as authorized Medical Institutions apart from Government Hospitals for medical treatment and reimbursement of medical claims.

It is brought to the notice of the Executive Council that at present the Pondicherry University (Medical Attendance) Rules on par with the provision contained in the CCS (Medical Attendance) Rules 1944 as amended from time to time are being followed in this University and the University has approved the following Private Hospitals as Authorized Medical Institutions apart from Govt. The Chairperson gave a brief welcome and the following Agenda items were taken for treatment.

The Committee after in depth deliberations of various issues resolved the following:-

### 1. Purchase of Generic Medicine for the Health Centre:

After in-depth deliberations, it was decided to purchase generic medicines only for the University Health Centre. The list was perused and approved by the Committee.

### 2. To improve the Health Services including Medical emergency situations in the Campus:

The Medical Officer suggested improving the manpower requirements required for the health centre.

During the discussion, PIMS has come forward to provide the ambulance (PEARS) for emergency, and retrieval services the patient in the University Campus with all paramedical staff, without any charges.

#### 8. To renew the Terms and Conditions in the agreement of PIMS:

- a. The Chief Medical Officer and Medical Officer of the Health Centre will prescribe the Medicines and in case of non-availability of the Medicines, the PIMS will supply/issue medicines to the Faculty/Students/Non-Teaching Staff and Pensioners only after due certification of the Medical Officers and PIMs will ensure this before issuing Medicines.
- b. PIMS was directed to sort out the bills separately for Faculty, Students and Non-Teaching Staff along with all the prescriptions copy and type of treatment, with proper identification of the individuals for scrutiny and records. The Medical Superintendent of PIMs has agreed to send the bills, from the month of February 2020.
- c. PIMs was requested to ensure that treatment is given to the beneficiaries, who are eligible, as this provision is extended only to the stakeholders, ie., students, staff and faculty.
- d. PIMs was instructed to refer the patients for investigations to the Medical Officers of the University, only when they come for investigations.
- e. Any patient is admitted to PIMS, PIMS will charge only the rates applicable at CGHS and the excess amount may be required for the treatment may be collected from the patients at the time of admission itself. Administration will write to PIMS on this and a Circular will also be issued.
- f. PIMS was requested to send a report of their services with complete details of the Doctors attended and patients treated and monthly report to be submitted alongwith the claim.
- g. The Committee unanimously recommended to renew the contract with PIMS for a period of One year with effect from 01.04.2019 to 31.3.2020 with the revised rate, i.e., with 5% increase.
- h. PIMS has also agreed to provide the PEARS (PIMS Emergency Ambulance Retrieval Services) from today onwards (14.2.2020) with free of cost.

4. To review the Recognition of new Private Hospitals along with the existing one:

The Committee unanimously recommended to recognize the following four Private Hospitals alongwith the existing

- 1. The M.V.R Medical Centre, Lawspet, Puducherry.
- 2. Sri Manakula Vinayagar Medical College and Hospital, Madagadipet, Puducherry.
- 3. Be Well Hospitals Private Limited, Puducherry.
- 4. Dr. Mohan's Diabetes Specialities Centre, Puducherry.

The charges will be restricted to CGHS rates,

5. To provide suggestions on draft MoU between Vinayaka Mission's Medical College & Hospital, Karaikal and PU on implementation of Health services at Karaikal Campus:

The Dean, Medical Sciences informed that the Vinayaka Mission's Medical College & Hospital, Karaikal does have adequate facilities and therefore the Committee unanimously recommended to constitute a Subcommittee to visit the Campus and the Government General Hospital, Karaikal and recommend for further action.

# TO CONSIDER AND APPROVE COLLABORATION WITH INDIAN AIR FORCE FOR PRIOR LEARNING FOR HIGHER EDUCATION OF AIR FORCE PERSONNEL

It is submitted that Air Marshal Lakshmi Narayan Sharma, Head of Directorate of Education, Indian Air Force sent a request letter to Hon'ble Vice Chancellor, Pondicherry University with a request to Recognize Prior Learning (RPL) considering the intensive and exhaustive training provided for a fairly long duration both to officers and airmen. The Indian Air Force has put-up the following two proposals for consideration:

#### 1. For Airmen:

The prior learning in the form of exhaustive ab-initio. On Job Training (OJT) and in-service training of air warriors may be considered as equivalent of first and second year of UG courses offered by the Universities under UGC and they may be permitted to appear directly in the final year of UG degree.

### 2. For Officers:

The ab-initio training, On Job Training and mandatory in-service courses coupled with management skills and job experience i/r/o IAF Officers may be considered as service experience and the same may be reckoned as admission criteria to permit them while taking admission directly in the final year of PG & MBA courses.

Andhra University & Jamia Millia Islamia University recognized the above proposals of the IAF and signed MoU with these institutions. In light of these two MoUs, IAF now requesting the Pondicherry University to Recognize Prior Learning so that the concerned IAF officers will come to Pondicherry University for signing MoU particularly with DDE offered PG and UG degrees.

Therefore, it is submitted for the consideration and approval of the Executive Council.

# TO CONSIDER AND AMEND THE EXISTING VERSION OF STATUTE No.36(1)(a) REMOVING THE SENTENCE PARTIALLY "SUFFERS FROM CONTAGIOUS LEPROSY"

Shri Surat Singh, Deputy Secretary to the Govt. of India, Ministry of Human Resource Development, New Delhi vide his letter dt. 14.06.2018 has enclosed copies of two Interim Orders dt. 11.01.2018 and 24.4.2018 of Supreme Court of India in W.P. (Civil)No.1151 of 2017 filed by Vidhi Centre for Legal Policy Vs. Union of India & Others with a request to furnish the comments and also to consider the matter in the Statutory Body Meetings of our University.

From Order dt. 11.01.2018, it has been observed that Ms. Pinky Anand, learned Additional Solicitor General appearing for the Union of India submitted that she has instructions to state that "wherever there will be any provision which can be viewed as discriminatory or prejudicial to the persons suffering from leprosy, that shall be adequately dealt with. When she says that adequately dealt with, she means, as we have been apprised, corrective/remedial measures shall be taken. At this juncture, we can only say that the legislations when came into force, the disease was viewed in a different manner, possibly without any cure, but today when the advancement of science has taken place and there is a cure for the same, corrective steps are imperative. And we are sure that the apposite steps shall be taken. If there will be any other law containing similar provision that shall also be looked into".

Further, the Hon'ble Court has given direction therein to all the State Governments to look into their legislations and carry out similar exercises so that there will be no such discrimination. From another Order dt. 24.04.2018, it has been observed that Ms. Pinky Anand, Additional Solicitor General has stated that the Central Government is taking steps to delete the provisions from number of enactments which cast stigma on the persons who are suffering from leprosy and also create a disability for them.

In this regard, based on the approval of the Executive Council Meeting held on 26.10.2018 vide Resolution No. 2018.132.49 and on the basis of the approval letter vide No.F.39-4/2019-CU-I dated 06.12.2019 with the assent of the Hon'ble President of India in his capacity as the Visitor of Pondicherry University to the proposal for amendment in Statute No.27(1) (a) relating to removal of the words "suffers from contagious Leprosy" and same has already been removed from the Statutes of the Pondicherry University.

Under these circumstances, it is submitted that in our Pondicherry University Statute No.36(1), under heading "<u>DISQUALIFICATIONS</u>", it is stated that " a person shall be disqualified for being chosen as, and for being a Member of any of the Authorities of the University".

(a) if he is of unsound mind or is a deaf-mute or suffers from contagious leprosy".

Submitted for consideration of amendment of the above Statute No. 36(1)(a) for deleting the sentence "suffers from contagious leprosy" partially, as the leprosy is at present absolutely curable and there should be no discrimination. The Statement showing the existing version and the amended version of the Statute with justification is enclosed.

#### I. MINUTES OF THE DPC MEETING DATED 21-10-2019:

#### (i) Consideration of LDCE held on 12-11-2017:

Based on the circular dated 06.06.2012, 17.12.2014, 27.05.2016, 39 Data Entry Operators and 5 Junior Assistants have applied. Of which one Mr. S. Ramesh has resigned the post and 4 Junior Assistants were found not eligible.

Accordingly, 43 employees [38 DEO (on contract) + 4 (DEO-On Contract in DDE) + 1 Junior Assistant] were called for LDCE. LDCE was conducted on 12.11.2017 to the eligible 40 employees out of 43 (DEO working in DDE -2 + Jr. Asst. -1 = 3 are Absent). Subsequently, Smt. N. Sarasvathy who had attended the written test resigned the post on 12.01.2018.

The PU SC/ST Employees Welfare Association had filed a case against the conduct of LDCE vide W.P.No.28980 of 2017 in which the Hon'ble Court in its order dated 17.11.2017 had granted stay of the permanent appointment to the post of Data Entry Operators but the Hon'ble permitted the selection process to continue

subject to the result of Writ petition by its interim order dated 17.11.2017. Subsequently the Hon'ble High Court of Judicature at Madras dismissed the Writ Petition on 20.12.2018.

Further it has been approved that the posts earmarked for Junior Assistants may also be filled with existing DEO's on contract, since present Draft Cadre Recruitment Rules for the post of DEO are to be filled on 100% Direct Recruitment basis and no provision is made for promotion among Junior Assistants and also one Junior Assistant who had applied for the written exam didn't attend the written test.

Accordingly, the Minutes of the Departmental Promotion Committee in its meeting held on 21.10.2019 have considered the appointment of Data Entry Operators under LDCE quota and recommended the overall Merit List & Selection List to the post of DEO on regular/tenure basis in the Level-4 of Pay Matrix.

Subsequently, the above Minutes were placed for administrative approval. Wherein the University Authorities has given approval only to 7 regular posts and 4 tenure posts against UGC Scheme (i.e. Centre for Social Exclusive & Inclusive Policy-2 & Centre for Women Studies-2) except 12 DDE posts and remarked that due to the poor financial situation in Directorate of Distance Education, a policy decision has been taken not to fill in DDE posts and the recommendations of the DPC minutes dated 21.10.2019 was regulated accordingly.

Hence, Appointment orders were issued to 7 employees on regular basis and 4 employees on tenure basis against UGC Scheme posts (Centre for Social Exclusive & Inclusive Policy-2 & Centre for Women Studies-2) subject to ratification by the Executive Council.

The University appointed three Senior Technical Assistant (Computer) viz Shri E. Malanco, Shri P. Elavarasan and Shri S. Manikandan on contract basis in the Time Scale of Rs.5500-175-9000 (GP 4200) with all allowances and posted at Centre for Bioinformatics with due selection procedures.

Periodic representations were received from the three Senior Technical Assistants towards the regularization of their services.

A Sanction order was issued by Department of Biotechnology, Govt. of India, New Delhi in April 2018 to convey the approval of continuation of Bioinformatics Programme in Pondicherry University for the 14<sup>th</sup> Financial Commission Cycle from April 1, 2017 March 31, 2020. The Ministry also informed that the absorption of manpower will be highly important for the Centre to maintain the sustainability beyond March 31, 2020.

The Ministry also conveyed the approval of various technical positions which includes 4 postings of Computer Operation/Programmers/EEO in the Pay Band of Rs. 9300-34800 with Grade pay of Rs. 4200 which is similar to the pay scale of Senior Technical Assistant in the University.

A memorandum of Agreement is also entered between Pondicherry University and Department of Biotechnology, Govt. of India, New Delhi which states that host institution should absorb the positions in order to sustain the activities if the Centre.

A committee was constituted to look in to the matter of three Senior Technical Assistant with an external expert from DBT and the meeting held on 19<sup>th</sup> and 20<sup>th</sup> February 2020 in Pondicherry University.

Accordingly the above matter was placed before the Executive Council in its meeting held on 24<sup>th</sup> February 2020 and the council resolved to confirm the services of these staff members subject to the continuance of support from DBT and refer to UGC for approval of absorption of these three Technical Staff (as per clause 3.0 of MOA between Pondicherry University and DBT)

In the past, the Executive Council had approved the absorption of staff appointed in the Bioinformatics Centre sanctioned under DBT funds without referring the matter to UGC vide EC Resol.No.93.93 dated 15.11.1993 and 2006.202 dated 09.10.2006.

The above matter is again submitted before the Executive Council for its re-consideration for the absorption of three Senior Technical Assistant (Computer) appointed in the Centre for Bioinformatics along with the posts.
