1. The number of request for Internship / Course Project (External) at no time may be more than the 10% of the sanctioned intake of the relevant PG programme of the University.

2. Such internship / course project requests may be allowed to be decided by the Head of the concerned Department / Centre.

3. The concerned Department / Centre to take the responsibility for the accommodation of the external students allowed for Internship(s) and Course Project.

4. The proposed fund / fee collected for such Internship(s) and Course Project may be considered as follows.

- i). For Dry labs : ₹ 5,000/- (1-3 months) for Internship
₹ 10,000/- (4-6 months) for Course Project
- ii). For Wet labs : ₹ 7,500/- (1-3 months) for Internship
₹ 15,000/- (4-6 months) for Course Project

1. Fund / Fee may be collected / remitted in the EMSF account of the University and it may be allowed to be claimed by the concerned department based on the request.



Based on the recommendations of the Committee and the approval of the competent authority, the following guidelines / charges for accommodation of outside students in the University Departments / Centres for Internship/ Course Project (External) are approved, subject to ratification in the Academic Council / Executive Council of the University;

1. The number of request for Internship / Course Project (External) at no time may be more than the 10% of the sanctioned intake of the relevant PG programme of the University.
2. Such internship / course project requests may be allowed to be decided by the Head of the concerned Department / Centre.
3. The concerned Department / Centre to take the responsibility for the accommodation of the external students allowed for Internship(s) and Course Project.
4. The proposed fund / fee collected for such Internship(s) and Course Project may be considered as follows.

i). For Dry labs	: ₹ 5,000/- (1-3 months) for Internship ₹ 10,000/- (4-6 months) for Course Project
ii). For Wet labs	: ₹ 7,500/- (1-3 months) for Internship ₹ 15,000/- (4-6 months) for Course Project
5. Fund / Fee may be collected / remitted in the EMSF account of the University and it may be allowed to be claimed by the concerned department based on the request.



The REGISTRAR, Pondicherry University, is duly authorised to enter into and sign the MOU on behalf of Pondicherry University, Puducherry (hereinafter called as 'PU').

AND

SOCIETY FOR ELECTRONIC TRANSACTIONS AND SECURITY (SETS) which is an initiative of the Office of Principal Scientific Advisor (PSA) to Government of India specializing in the area of Information Security, (hereinafter called as 'SETS').

Background of the institutions

Pondicherry University offers Postgraduate and Doctoral research programs in multiple disciplines leading to Masters and PhD degrees from its campuses at Puducherry (Main), Karaikal, Mahe, Yanam and Andaman & Nicobar Islands. Post-doctoral Research Fellowships and National and International Collaborative Research Projects are also undertaken by faculty.

Society for Electronic Transaction and Security is a Research and development organization - an initiative of the Office of Principal Scientific Advisor (PSA) to Government of India. Dr. R. Chidambaram through the Office of the PSA. SETS is registered as a non-profit society under the Societies Act of 1860 in May 2002 and its register no. S42605 of 2002. SETS is working with a vision of becoming premier R&D institute in India, in the area of Information Security. The Mandate to SETS continues to (a) carry out Directed Basic Research and develop Tools and Techniques in the area of Cryptology and Secure Protocols, (b) provide a Platform for translating basic research into Prototypes for data security and analysis, (c) to create coherent synergy and act as a Bridge between Academia, R&D labs and industry for collaborative R&D towards Product development and, (d) to provide Consultancy Services and Training on Cyber Security domain for industry, academia, Government and Critical Infrastructure Sectors.



- iv. Organization of National events such as Seminars/ Conferences with the help of PU.
- v. To provide necessary permission for visiting SETS facilities by PU Faculty and Students.
- vi. Provide the opportunities to potential students at Undergraduate and post graduate level for Internships & projects as per the terms of SETS and research guidance to Ph. D students.
- vii. Assisting PU in setting-up advanced labs in the area of Cyber Security.
- viii. To provide technical assistance and guidance to design the special subjects and value added courses.
- ix. Any other mutually agreed subjects.

4. JOINT RESPONSIBILITIES OF PU AND SETS:

- i. To work on Research projects in the evolving technological areas, including Cyber security, which will have direct implications for the specific needs of the country with a focus to work on Cyber security projects in Electronics, Communication, Computing & InformationTechnology, Mathematics, Statistics areas which includes the fields related to Hardware security, Cryptology, Network Security, DataSecurity,Critical Infrastructure Protection etc. applying advanced technologies such as AI, Machine Learning, Deep Learning, Game Theory, Embedded and VLSI technologies, Physically Unclonable functions (PUF), IOT, Big Data, Cloud areas.
- ii. Nominate Coordinators as nodal contacts to represent the organization and promote interface so as to plan, implement, monitor and review the various activity schedules from time to time.
- iii. SETS personnel, may be allowed to enroll for their Ph.D./M.Tech. (Research) at PU, subject to fulfilling their eligibility criteria and as well as all other academic regulations of PU.

- iv. SETS scientists may act as Research supervisors jointly with PU faculty or as per the norms of PU in which case the research student may be positioned at SETS to carry-out the research activity.

- vi. Conduct collaborative events/workshops/ training programs in the identified areas.
- vii. SETS and PU can work together in providing contract research to industries, consultancy services, corporate training to government agencies, banks and other public or private sector organizations in the areas of Cyber security contributing the expertise available with SETS and PU.
- viii. Any software/hardware material, product specifications, designs, financial information, documents, training material, courseware, syllabus, schedule etc. shall be deemed to be in private domain and it shall not be made public or shared with any other party without the prior written consent of the party which owns it. In the event of any of the parties becoming legally compelled to disclose any confidential information, such party shall give sufficient notice to the other party so as to enable the other party to seek a timely protective order or any other as appropriate relief. If such an order or other relief cannot be obtained, the party being required to make such a disclosure shall make the disclosure of the confidential Information only to the extent that is legally required of it and no further.

8. INTELLECTUAL PROPERTY RIGHTS:

Ownership of any and all intellectual property created / developed through collaborations under this MOU will be determined between the Parties through mutual consultation and recorded in writing as an addendum/amendment/agreement separately on a case- to -case basis prior to starting of work.

9. EFFECTIVE DATE AND VALIDITY:

- i. This MOU shall be valid for a period of **5 years** from the date of signing of the MOU.
- ii. The validity of the MOU may be extended by mutual agreement in writing and signed by both the parties

In such cases no Party shall incur any liability whatsoever.

Notwithstanding expiration or termination of this MOU for any reason whatsoever, provision of Article 7, 8 and 11 of this MOU shall survive such termination or expiration for the period of Five (5) years.

11. DISPUTE RESOLUTION AND ARBITRATION:

In case any dispute/claim arises between the Parties with respect to the MOU, including its validity, interpretation, implementation or alleged material breach of any of its provisions or regarding a question, including the questions as to whether the termination of this MOU by one Party hereto has been legitimate, both Parties hereto shall endeavor to settle such dispute amicably. If the Parties fail to bring about an amicable settlement within a period of 30 (thirty) days, dispute shall be referred to the sole arbitrator appointed mutually by PU and SETS. Arbitration proceedings shall be conducted in accordance with the provisions of the Arbitration and Conciliation Act, 1996 and Rules made there under, or any legislative amendment or modification made thereto. The venue of the arbitration shall be Chennai. The award given by the arbitrator shall be final and binding on the Parties. The language of arbitration shall be English. The common cost of the arbitration proceedings shall initially be borne equally by the Parties and finally by the Party against whom the award is passed. Any other costs or expenses incurred by a Party in relation to the arbitration proceedings shall ultimately be borne by the Party as the arbitrator may decide. Courts in Chennai / Puducherry only shall have the exclusive jurisdiction to try, entertain and decide the matters which are not covered under the Arbitration and conciliation Act.

12. GOVERNING LAW:

This MOU shall be governed by and interpreted in accordance with the laws of India.

14. NOTICES:

Any notices to be given hereunder except for termination, shall be given by either party to the other may be effected either by personal delivery in writing or by fax with a second copy sent by airmail, registered or certified, postage prepaid with return receipt requested, or by recognized international courier service. Mailed notices shall be addressed to the parties at the addresses appearing in the introductory paragraph of this Agreement, but each party may change such address by written notice in accordance with this paragraph. Notices delivered personally will be deemed communicated as of actual receipt. Mailed notices will be deemed communicated as of four (4) days after mailing.

Either party shall keep other party, its affiliates, shareholders, officers, directors, employees, agents, representatives, and customers indemnified and harmless from and against any and all costs, liabilities, losses, and expenses (including, but not limited to, reasonable fees of attorneys) arising out of any claim, suit, action or proceeding (each, an "Action"), for any act(s) and omissions of such party under any proposal(s) to Prospective client(s) or any resulting contract(s) therefrom or any incidental matter or in any way arising therefrom.

16. ASSIGNMENT AND TRANSFER:

Any and all rights, duties and obligations of the parties under this MOU shall not be transferred or assigned by either party to any third party without prior written consent of the other party.

17. NON WAIVER:

The failure or neglect by either of the Parties to enforce any of the terms of this MOU shall not be construed as a waiver of its rights preventing subsequent enforcement of such provision or recovery of damages for breach thereof.

The headings shall not limit, alter or affect the meaning of the Clauses headed by them and are solely for the purpose of easy reference.

23. ENTIRE MOU:

This MOU, sets forth the entire understanding of the Parties with respect to the subject matter hereof, and supersedes all prior oral and written agreements, understandings, representations, conditions and all other communications relating thereto.



- vi. Conduct collaborative events / workshops / training programs / seminars / conferences / Skill Development in the identified areas of mutual interest.
- vii. ERNET India and PU can work together in providing contract research to industries, consultancy services, skill development programs, corporate training to government agencies, banks and other public or private sector organizations in the areas of expertise available with ERNET India and PU.

TO CONSIDER AND APPROVE THE PROPOSED AMENDMENT TO STATUTE 1(1) OF THE PONDICHERRY UNIVERSITY ACT & STATUTES

Statute1(1) of the Pondicherry University Act & Statutes provide for appointment of Chancellor of the University by the Visitor from a panel of not less than 3 persons recommended by the Executive Council from amongst persons of eminence in the Academic or Public life of the Country:

The practice followed since the inception of Pondicherry University and as in other Central Universities is that the Hon'ble Vice – President of India is usually appointed as the Chancellor of the University.

To follow in line with the practice, amendment to Statute1(1) is proposed (Annexure) for consideration.

Procedure for Amendment of Statutes (Section 26 (3) of Pondicherry University Act): (copy enclosed)

26 (3) Every new Statute or addition to the Statute or any amendment or repeal of a Statute shall require the assent of the Visitor who may assent thereto or withhold assent or remit to the Executive Council for consideration.

26 (4) A new Statute or a Statute amending or repealing an existing Statute shall have no validity unless it has been assented to by the Visitor.

- (3) Every new Statute or addition to the Statute or any amendment or repeal of a Statute shall require the assent of the Visitor who may assent thereto or withhold assent or remit to the Executive Council for consideration.
- (4) A new Statute or a Statute amending or repealing an existing Statute shall have no validity unless it has been assented to by the Visitor.
- (5) Notwithstanding anything contained in the foregoing sub-sections, the Visitor may make new or additional Statutes or amend or repeal the Statutes referred to in sub-section (1) during the period of three years immediately after the commencement of this Act:

Provided that the Visitor may, on the expiry of the said period of three years, make, within one year from the date of such expiry, such detailed Statutes as he may consider necessary and such detailed Statutes shall be laid before both Houses of Parliament.
