Introduction: Meaning and Scope of Anthropology. Divisions of Anthropology. Scope of social cultural Anthropology and its relations with other branches of Anthropology, social sciences, life sciences, medical sciences and humanities. Usefulness of anthropology. Social institutions.

### Unit 1:
