INSTRUCTIONS TO THE CANDIDATES

Based on the cancellation of admission by some of the admitted students, sliding was done and as a result following vacancies are available in M.Com (Accounting and Taxation) and admission counseling for the same will be conducted online.

Applicants would be called for counseling in the ratio of 1:5 in order of merit from the selection list. For one vacancy, five eligible applicants would be called for counseling. Admission will be made through online counseling based on merit; only for people who have registered through the link provided. The schedule is as follows:

3. (Keep your M.COM (Accounting & Taxation) Entrance Exam Register Number as the Subject of the email.)
  - i. X Std or equivalent certificate/mark statement along with age proof.
  - ii. H.SC or its equivalent certificate/mark statement
  - iii. Degree/provisional certificate of the qualifying degree examination along with mark statements (if available).
  - iv. O.B.C. with Non-Creamy Layer certificate/E.W.S. recently issued (issued after 1<sup>st</sup> January 2020) by the competent authority, in case of OBC/EWS candidates, respectively (E.W.S. certificate format).
  - v. Recently issued SC/ST/PH/Pondicherry Residence certificate from the competent authority.
  - vi. Migration/Transfer certificate and conduct certificate from the institution last studied.
  - vii. Recently taken colour passport size photograph.
