



#### CFES 101: ART, RELIGION AND CULTURE IN EUROPE (1300 – 1600)

Credits Allotted	4
Instruction Method	Lectures and seminars
Evaluation Method	Written tests, term papers, seminars and book review.
Course Duration	One semester
Contact Hours	4 per week

#### **Course Rationale**

The period from 1300 to 1600 witnessed fundamental transformations that shaped European society for the next four hundred years. The present course focuses on the transition from the medieval to the modern, a period of cultural revival, religious upheaval and overseas expansion. It familiarizes the students with the demographic, economic, technological and socio - cultural transformations in Europe from the fourteenth to sixteenth century.

#### **Course Content**

#### **UNIT 1: Europe in the Later - Middle Ages**

Climatic changes - The Black Death and its consequences – Papal Schism and the late medieval Church – Late medieval European society.

#### **UNIT 2: The Civilization of the Renaissance**

The Rise of Italian City States and the Merchant Class – Renaissance Humanism – Art in Renaissance Italy –Northern Renaissance - John Guttenberg and the coming of the book.

#### **UNIT 3: Reformation of Religion**

Wycliffe and Hus - Martin Luther and the Protestant Reformation – John Calvin and Calvinism – The English Reformation –Catholic Reform and the Counter Reformation – Religious conflicts.

#### **UNIT 4: Voyages of Exploration**

Silver Shortage and the search for African gold – Mediterranean Empires – Shift to the Atlantic – Technology of ships and navigation – Portuguese Exploration and the Sea Route to India - Spanish Exploration – Europe encounters a New World.

#### **UNIT 5: Conquest and Colonization**

Atlantic colonization and the growth of slavery – Spanish conquest of America – American Silver and the Price Revolution - The Columbian Exchange.

#### CFES 102: STATES AND NATIONS IN EUROPE (1500-1800)

Credits Allotted	4
Instruction Method	Lectures and seminars
Evaluation Method	Written tests, term papers, seminars and book review.
Course Duration	One semester
Contact Hours	4 per week

#### **Course Rationale**

The course is designed to give the students a comprehensive picture of the emergence, and expansion of European states and nations from 1500 – 1800. It discusses the development of the state, society and economy of Europe with special reference to developments in science, technology and ideologies. The geographical, commercial, political, intellectual and scientific revolutions which paved the way for the predominance of Europe over the rest of the world are highlighted.

**Course Content UNIT 1: Europe in 1500** Rise of New Monarchies - Transition from Feudalism to Capitalism.

#### **UNIT 2: European State System**

Absolutism – Absolutism of the Habsburgs in Spain – England: Tudors and the early Stuarts – France: Bourbon Absolutism - Eastern Europe: Rise of Muscovy.

#### **UNIT 3: Europe in Crisis**

The Thirty Years War - The Crisis of the mid – seventeenth Century - English civil war Revolution, ferment in ideas and society- Restoration and its aftermath.

#### **UNIT 4: Mercantilism and Colonial Rivalries**

Economic Nationalism and Mercantilism - The Dutch Commercial Empire - Colonial policy of major European powers - The Hegemony of Britain.

#### **UNIT 5: European Revolutions**

Scientific and Intellectual Revolution – Industrial Revolution - Enlightenment – The French Revolution.

#### **Course Rationale**

The course aims to familiarize the students with the role of regional organizations in contemporary world politics with the example of European Union. It facilitates the understanding of the internal political and economic dynamics of European Union and assess its significance in international politics. It seeks to enable students to comprehend the issues and challenges of European integration and to analyze its internal and external impacts.

#### **Course Contents**



#### **Course Rationale**

- To impress on the students, the significance of the emergence of modern nation state system in Europe and to grasp its larger implications, especially how the policies and mechanisms of the European nation states resulted in World Wars.
- To make them understand and appreciate the political, socio-cultural and economic dynamics of Europe during the modern period.
- To enable the students to trace how the idea of Europe was shaped during the period, the challenges faced by Europe in this process and how Europe responded to them.





#### CFES 101: ART, RELIGION AND CULTURE IN EUROPE (1300 – 1600)

Credits Allotted	4
Instruction Method	Lectures and seminars
Evaluation Method	Written tests, term papers, seminars and book review.
Course Duration	One semester
Contact Hours	4 per week

#### **Course Rationale**

The period from 1300 to 1600 witnessed fundamental transformations that shaped European society for the next four hundred years. The present course focuses on the transition from the medieval to the modern, a period of cultural revival, religious upheaval and overseas expansion. It familiarizes the students with the demographic, economic, technological and socio - cultural transformations in Europe from the fourteenth to sixteenth century.

#### **Course Content**

#### **UNIT 1: Europe in the Later - Middle Ages**

Climatic changes - The Black Death and its consequences – Papal Schism and the late medieval Church – Late medieval European society.

#### **UNIT 2: The Civilization of the Renaissance**

The Rise of Italian City States and the Merchant Class – Renaissance Humanism – Art in Renaissance Italy –Northern Renaissance - John Guttenberg and the coming of the book.

#### **UNIT 3: Reformation of Religion**

#### **UNIT 4: Voyages of Exploration**

#### **Course Rationale**

The course is designed to give the students a comprehensive picture of the emergence, and expansion of European states and nations from 1500 – 1800. It discusses the development of the state, society and economy of Europe with special reference to developments in science, technology and ideologies. The geographical, commercial, political, intellectual and scientific revolutions which paved the way for the predominance of Europe over the rest of the world are highlighted.


