The main objectives of this Authority is to educate and sensitize people regarding their legal rights, to propagate the objectives of the National Legal Literacy Mission, to highlight our solidarity and support to the case of the underprivileged, to highlight the constitutional mandate of social justice, equality and equal opportunities to the weaker sections etc., The horizon of our service does not stop with that. Ragging is a menace found in many educational institutions and professional colleges. Hon'ble Supreme Court of India and some State Governments have taken steps to penalize the acts of ragging in educational institutions. The Legal Services Authorities are focusing on special legal literacy campaigns in schools and colleges on anti-ragging laws.

I am enclosing herewith the orders passed by the Hon'ble Supreme Court of India and the instructions issued by the University Grant Commission. 
