- 4. Number of years of experience in the field along with address of the Offices/Organizations/ Educational Institutions where at present Catering services are to be provided.
- 5. List of the Clients / Organizations to where you have been supplied in the last 2 years.
- 6. Contract is for a period of 1 year renewable on performance/requirement basis. Supply of Tea & Snacks is required during the month of April to June & Nov to Jan. For the remaining months tea alone is required.
- 7. Rates inclusive of paper plates & paper tea cups.

- 17. Tea & snacks is hereby to be supplied at the specified time mentioned below on week days and sometimes on Sundays & Public Holidays or any other time as decided by the University.

- 19. The Snacks items to be supplied to the individuals hygienically with gloves etc. conforming to high standards.
- 20. Approximate requirement ranges from per day 70 to 500 per session (two sessions per day)
- 21. Quantity of items will be tested by the committee for the shortlisted tender and based on quality evaluation tender will be selected.
- 22. One person should be appointed for service of the refreshments.
- 23. The person engaged should wear a face mask and gloves.
