- 4. You are requested to produce a Vaccination Certificate before the concerned unit/Supervisor for atleast one dose of the vaccine before requesting for entry.

In case you have suffered from Covid in the past, please produce evidence of being asymptomatic for at least 07 days and a Covid negative certificate taken within 72 hrs. prior to seek permission to enter campus.

- 5. You agree to the University-wide testing via Rapid Antigen Test (RAT) as and when required by the University.
- 6. That it is incumbent that you will bring to the notice of the concerned school or research/academic supervisor on any health issues you faced within the campus or in your current residence outside campus. For any health care needs the Departmental Covid Task force and the Health Centre of the campus will be the first point-of-contact and you will have to follow the recommendations of the health centre medical officer at that time. You will fully cooperate, consent and subject yourself to any tests/medical examination or inquiry by the state/University officials freely and unbiasedly if the need arises in this case.
- 7. You are strictly advised not to come to the University if you are from the containment zone or any of your family members have any symptoms of COVID19.
- 8. That it is incumbent that you are strictly advised against any overstay and also bring to the notice of the University authorities of any transgression and stay in the hostel/residence by yourself or your other scholar friends to protect the health and safety of the campus community.
- 9. Failure of adherence or in the event of non-compliance to the point immediately above will attract disciplinary action against you as per the University regulations.
- 10. It will be the collective responsibility of the respective Department/Centre and the research supervisor to ensure that the SOPs are being followed during the permitted period of entry in the University and work area of the concerned unit.
- 11. You will follow the schedules and instructions issued by the University for the phase-wise return of the students, scholars, and research fellows to the campus.

- 12. The University or the concerned Supervisor/Head/Dean will not take any responsibility in the unforeseen event of state or central authorities enforcing any restrictions/lockdown.
- 13. As far as maintaining student-related infrastructure, all attempts will be made to ensure provision of basic needs like clean drinking water and sanitized common spaces.
- 14. The University and Department Head/Supervisor/Dean do not make any guarantees of smooth functioning during unforeseen events in the situation locally. During any such difficult periods, minimum staff strength may be maintained on campus and it is your personal responsibility to ensure you have the essential hygiene and medical supplies personally required for your health and safety, in addition to the basic amenities the University provides. It is expected that you will volunteer to take care of yourself and not obstruct the University's efforts in stabilizing such situations.
- 15. By reading this you are now well versed with the conditions of entry/re-entry into the University campus.
